# 1909

### Chapter 152.

An Act prohibiting the throwing of sawdust and other waste material into Highland Lake, or any of its tributaries in the City of Westbrook, towns of Windham, Gray and Falmouth, and into Mill Brook in Westbrook, all in the County of Cumberland.

### Be it enacted by the People of the State of Maine, as follows:

Section I. No person shall cast or throw into Highland lake or any of its tributaries in the city of Westbrook and towns of Windham, Gray and Falmouth, or into Mill Brook in Westbrook, all in the county of Cumberland, any sawdust, shavings, bark or other mill waste or refuse of any kind, or place or deposit such sawdust, shavings, bark or other mill waste or refuse of any kind along the banks of said waters in such manner that the same shall fall or be washed into said brook or lake.

Section 2. Whoever violates any of the provisions of this Penalty for violation act shall be subject to a penalty of not less than five nor more violation of this act. than fifty dollars and costs for each offense.

Section 3. This act shall take effect July first, nineteen hundred and nine.

Approved March 15, 1909.

### Chapter 153.

An Act authorizing the Liberty and Belfast Telephone and Telegraph Company to increase its capital stock.

Be it enacted by the People of the State of Maine, as follows:

The Liberty and Belfast Telephone and Telegraph Company is hereby authorized to increase its capital stock from two thousand dollars to ten thousand dollars.

Approved March 15, 1909.

### Chapter 154.

An Act to regulate fishing in Mount Blue Stream, the outlet of Mount Blue Pond, in the town of Avon, in Franklin County.

Be it enacted by the People of the State of Maine, as follows:

Section I. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in Mount Blue stream, so called, the outlet of Mount Blue pond, in the town of Avon, in Franklin county, except on Tuesday, Thursday and Saturday of each week, on which days it shall be lawful to fish in said stream in accordance with the general law of the state.
