Chapter 152.

An Act prohibiting the throwing of sawdust and other waste material into Highland Lake, or any of its tributaries in the City of Westbrook, towns of Windham, Gray and Falmouth, and into Mill Brook in Westbrook, all in the County of Cumberland.

Be it enacted by the People of the State of Maine, as follows:

Section 1. No person shall cast or throw into Highland lake or any of its tributaries in the city of Westbrook and towns of Windham, Gray and Falmouth, or into Mill Brook in Westbrook, all in the county of Cumberland, any sawdust, shavings, bark or other mill waste or refuse of any kind, or place or deposit such sawdust, shavings, bark or other mill waste or refuse of any kind along the banks of said waters in such manner that the same shall fall or be washed into said brook or lake.

Throwing sawdust into Highland lake and tributaries, or into Mill brook, prohibited.

Section 2. Whoever violates any of the provisions of this act shall be subject to a penalty of not less than five nor more than fifty dollars and costs for each offense.

Section 3. This act shall take effect July first, nineteen hundred and nine.

When act shall take effect.

Chapter 153.

An Act authorizing the Liberty and Belfast Telephone and Telegraph Company to increase its capital stock.

Be it enacted by the People of the State of Maine, as follows:

The Liberty and Belfast Telephone and Telegraph Company is hereby authorized to increase its capital stock from two thousand dollars to ten thousand dollars.

Chapter 154.

An Act to regulate fishing in Mount Blue Stream, the outlet of Mount Blue Pond, in the town of Avon, in Franklin County.

Be it enacted by the People of the State of Maine, as follows:

Section 1. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in Mount Blue stream, so called, the outlet of Mount Blue pond, in the town of Avon, in Franklin county, except on Tuesday, Thursday and Saturday of each week, on which days it shall be lawful to fish in said stream in accordance with the general law of the state. Dur-

ing the open season on said Mount Blue stream it shall be unlawful for any one person to take, catch or kill more than twenty-five fish in all in any one day taken from said waters. Whoever violates any of the provisions of this act shall be subject to the same penalty as is provided in the general law of the state for the illegal fishing for and catching of trout and land-locked salmon.

Section 2. In all prosecutions under this act, municipal and police courts and trial justices within their respective counties shall have, upon complaint, original and concurrent jurisdiction with the supreme and superior courts, and all fines, forfeitures and penalties received for any violation of this act shall be paid forthwith by the person receiving the same to the state treasurer, and credited to fines and license fees for the protection of birds and game.

Chapter 155.

An Act to amend Section two of Chapter four hundred and seven of the private and special laws of nineteen hundred and three, relating to fishing in the tributaries to Brettun's Pond, in Livermore, in Androscoggin County.

Be it enacted by the People of the State of Maine, as follows:

mitted.

So much of section two of chapter four hundred and seven of the private and special laws of nineteen hundred and three, as prohibits fishing, in accordance with the general law of the state, in the tributaries to Brettun's pond, which pond is situated in the town of Livermore in Androscoggin county, is hereby repealed.

Chapter 156.

An Act to amend Section one of Chapter four hundred and seven of the private and special laws of nineteen hundred and three, relating to fishing through the ice in Grassy Pond, in the towns of Hope and Rockport, in Knox County.

Be it enacted by the People of the State of Maine, as follows:

mitted.

So much of section one of chapter four hundred and seven of the private and special laws of nineteen hundred and three, as prohibits fishing through the ice, in accordance with the general law of the state, on Tuesday and Saturday of each week, in Grassy pond, so called, in the towns of Hope and Rockport, in Knox county, is hereby repealed.
