Chapter 173.

An Act to regulate fishing in Marsh Stream, so called, in Waldo County, and also in its tributaries.

Be it enacted by the People of the State of Maine, as follows:

Section 1. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in Marsh stream, so called, in the county of Waldo, except it shall be lawful to fish, in accordance with the general law of the state, from the mouth of said stream up as far as the bridge near Isaac Cook's residence, on the South West branch, so called, and as far as the bridge near Freeman Ritchie's residence, on the north west branch, so called. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in any of the tributaries to said Marsh stream, except during the month of May of each year it shall be lawful to fish in said streams in accordance with the general law of the state. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in any of the brooks flowing into Northern pond, so called, in the town of Monroe, in the county of Waldo. Whoever violates any of the provisions of this section shall be subject to the same penalty as is provided in the general law of the state for the illegal fishing for and catching trout and land-locked salmon.

Fishing in Marsh stream and tributaries, regulated.

—fishing in tributaries to Northern pond, prohibited.

—penalty.

Section 2. In all prosecutions under this act, municipal and police courts and trial justices, within their respective counties, shall have upon complaint, original and concurrent jurisdiction with the supreme and superior courts, and all fines, forfeitures and penalties received for violation of this act shall be paid forthwith by the person receiving the same to the state treasurer, and credited to fines and license fees for the protection of birds and game.

Court jurisdiction.

Approved March 15, 1909.

Chapter 174.

An Act to regulate fishing below Upper Dam, so called, in Oxford County.

Be it enacted by the People of the State of Maine, as follows:

Section 1. It shall be unlawful to fish for, take, catch or kill any kind of fish at any time in the pools from and below the dam to the big rock at the mouth of the river, at Upper dam, so called, in Oxford county, except in the ordinary way of casting with artificial flies or fly fishing.

Fishing below Upper Dam, regulated.

Section 2. Whoever violates any of the provisions of this act shall be subject to the same penalty as is provided in the
