Chapter 201.

An Act to authorize and empower Leone R. Cook and others, trustees, to convey certain interests in real estate to the inhabitants of the town of Yarmouth.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Leone R. Cook, Ferdinand B. Merrill, Frederic E. Gore, and William M. Bradley, trustees under the will of George W. Hammond, are authorized and empowered to convey all their interest as such trustees in and to the old Baptist meeting house property, so called, and the Bucknam lot, so called, each situated in Yarmouth, to the inhabitants of the town of Yarmouth, for the purpose of a town hall.

Section 2. Leone R. Cook, Ferdinand B. Merrill, Frederic E. Gore and William M. Bradley, trustees under the will of Ellen S. S. Hammond, are authorized and empowered to convey all their interest as such trustees in and to the old Baptist meeting house property, so called, situated in Yarmouth, to the inhabitants of the town of Yarmouth for the purpose of a town hall.

Chapter 202.

An Act to extend the charter of the Bluehill Trust and Banking Company.

Be it enacted by the People of the State of Maine, as follows:

Charter ex-

The rights, powers and privileges of the Bluehill Trust and Banking Company, which were granted by chapter two hundred and seventy-two of the private and special laws of eighteen hundred and ninety-five, and extended by chapter three hundred and ninety-one of the private and special laws of eighteen hundred and ninety-seven, and further extended by chapter one hundred and thirty of the private and special laws of eighteen hundred and ninety-nine, and further extended by chapter three hundred and fifty-six of the private and special laws of nineteen hundred and one, and further extended and amended by chapter three hundred and thirty-six of the private and special laws of nineteen hundred and three, and further extended by chapter two hundred and twenty of the private and special laws of nineteen hundred and five, and further extended by chapter two hundred and eighty-five of the public laws of nineteen hundred and seven, are hereby extended for one year; and the persons named in said act, their associates and successors, shall have all the rights, powers and privileges that were granted

them by said act, to be exercised in the same manner and for the same purpose as specified in said act; provided, however, that said company shall actually commence business as a trust company within said one year.

Approved March 16, 1909.

Chapter 203.

An Act to extend the charter of the Sagadahoc Trust Company.

Be it enacted by the People of the State of Maine, as follows:

The rights, powers and privileges of the Sagadahoc Trust Company, which were granted by chapter one hundred and fifty-two of the private and special laws of nineteen hundred and seven, are extended for one year; and the persons named in said act, their associates and successors shall have all the rights, powers and privileges that were granted them by said act to be exercised in the same manner and for the same purposes as specified in said act; provided, however, that said company shall actually commence business as a trust company within said one year.

Chapter 204.

An Act to incorporate the Maple Grove Electric Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Clarence A. Powers, James R. Thurlough, Charles M. Waldron, Isaac Conant and Albert T. Hoyt, their associates, successors and assigns are hereby made a body corporate by the name of the Maple Grove Electric Company.

Section 2. The said corporation is hereby authorized to transmit, supply, sell and distribute electricity, for light, heat and power, in and through all that portion of the town of Fort Fairfield which was formerly township letter D, range one, according to survey and plan of said letter D township made by Thomas Sawyer, except that portion of said township particularly described in chapter one hundred and sixty-six, private and special laws of eighteen hundred and eighty-seven, entitled an act creating the Fort Fairfield Village Corporation.

Purposes and powers.

Section 3. All locations upon streets, roads or ways in said town, necessary for the purposes of this act, are hereby granted and the municipal officers of said town of Fort Fair-
