Section 2. In all prosecutions under this act, municipal and police courts and trial justices, within their respective counties, shall have, upon complaint, original and concurrent jurisdiction with the supreme and superior courts, and all fines, forfeitures and penalties received for any violation of this act shall be paid forthwith by the person receiving the same to the state treasurer, and credited to fines and license fees for the protection of birds and game.

Chapter 213.

An Act to regulate fishing in Belgrade Stream, in Kennebec County. Be it enacted by the People of the State of Maine, as follows:

Section I. It shall be lawful to fish in Belgrade stream, so called, from Snow pond to Wing's mill dam, so called, on said stream, under the same restrictions as apply to fishing in the Belgrade chain of lakes.

Fishing in Belgrade stream. regulated.

Section 2. All acts or parts of acts inconsistent with this act are hereby repealed.

Chapter 214.

An Act to regulate the taking of fish from Lower Kezar Pond, in Fryeburg, Oxford County, Maine.

Be it enacted by the People of the State of Maine, as follows:

Section I. It shall be unlawful to take or catch any black bass, pickerel, or any other fish from Lower Kezar pond, Fryeburg, or any of its tributaries for sale, or to sell the same, and no person shall take more than fifteen pounds of fish in any one day from said Lower Kezar pond or its tributaries.

Fishing in Kezar pond and tributaries, regulated.

Section 2. It shall be unlawful to fish for, take or catch any of the fish mentioned in section one, while fishing through the ice in any of the above named waters except during the months of March and April, and then only as provided by the general regulated.
