Section 2. In all prosecutions under this act, municipal and police courts and trial justices, within their respective counties, shall have, upon complaint, original and concurrent jurisdiction with the supreme and superior courts, and all fines, forfeitures and penalties received for any violation of this act shall be paid forthwith by the person receiving the same to the state treasurer, and credited to fines and license fees for the protection of birds and game.

Chapter 213.

An Act to regulate fishing in Belgrade Stream, in Kennebec County.

Be it enacted by the People of the State of Maine, as follows:

Section 1. It shall be lawful to fish in Belgrade stream, so called, from Snow pond to Wing's mill dam, so called, on said stream, under the same restrictions as apply to fishing in the Belgrade chain of lakes.

Section 2. All acts or parts of acts inconsistent with this act are hereby repealed.

Chapter 214.

An Act to regulate the taking of fish from Lower Kezar Pond, in Fryeburg, Oxford County, Maine.

Be it enacted by the People of the State of Maine, as follows:

Section 1. It shall be unlawful to take or catch any black bass, pickerel, or any other fish from Lower Kezar pond, Fryeburg, or any of its tributaries for sale, or to sell the same, and no person shall take more than fifteen pounds of fish in any one day from said Lower Kezar pond or its tributaries.

Section 2. It shall be unlawful to fish for, take or catch any of the fish mentioned in section one, while fishing through the ice in any of the above named waters except during the months of March and April, and then only as provided by the general

laws, regulating the use of lines while so fishing. The number of pounds to be taken, as provided in section one.

Penalty.

Section 3. Whoever violates any of the provisions of this act shall be subject to the same penalty as is provided in the general law of the state for the illegal fishing for and catching trout and land-locked salmon.

Jurisdiction of courts.

Section 4. In all prosecutions under this act, municipal and police courts and trial justices within their respective counties, shall have upon complaint, original and concurrent jurisdiction with the supreme and superior courts, and all fines, forfeitures and penalties received for violation of this act shall be paid forthwith by the person receiving the same to the state treasurer, and credited to fines and license fees for the protection of birds and game.

Chapter 215.

An Act authorizing the payment of an annuity by the city of Portland to John Cousens.

Be it enacted by the People of the State of Maine, as follows:

Annuity to John Cousens, authorized.

The city council of the city of Portland may annually hereafter appropriate and pay to John Cousens, a former member of the fire department of said city, who received injuries while in the discharge of his duty, a sum not exceeding four hundred and seventy-five dollars.

Chapter 216.

An Act to regulate fishing in Little Big Wood Pond, Somerset County.

Be it enacted by the People of the State of Maine, as follows:

Ice fishing in Little Big Wood pond, prohibited for 5 years.

Section 1. It shall be unlawful to fish for, take, catch or kill any kind of fish in Little Big Wood pond, so called, in Somerset county, through the ice, for a period of five years from the time this act takes effect.

Penalty.

Section 2. Whoever violates any of the provisions of this act shall be subject to the same penalty as is provided in the general law of the state for illegal fishing.

Jurisdiction of courts.

Section 3. In all prosecutions under this act, municipal and police courts and trial justices in their respective counties shall have upon complaint original and concurrent jurisdiction with the supreme judicial and superior courts, and all fines, forfeit-
