For addition and changes to boiler house, necessitated by new buildings recently constructed, for changes in heating system of old buildings, for window guards on one ward of old buildings, and to settle deficit.

Said sum to be appropriated for the year nineteen hundred and nine, and to be expended under the direction of the trustees of insane hospitals.

In view of the emergency set forth in the preamble, this resolve shall take effect when approved.

### Chapter 189.

Resolve in favor of aid in building a Highway Bridge across the East Branch of the Penobscot River in the town of Medway.

Resolved, that the sum of twenty thousand dollars to be paid, ten thousand dollars in the year nineteen hundred and nine, ten thousand dollars in the year nineteen hundred and ten, be and hereby is appropriated from any unexpended moneys in the treasury, to aid in building a highway bridge across the East Branch of the Penobscot river in the town of Medway, in Penobscot county, on the highway from Medway to East Millinocket.

Provided, a sum of money be raised by the county, the towns of Millinocket, East Millinocket and Medway, or otherwise, which, together with the amount herein appropriated, shall be sufficient to complete said bridge, within two years from the date of the approval of this resolve, without further aid from the state.

Proviso.

Provided, also, that the location and erection of said bridge shall be under the supervision of the county commissioners of Penobscot county and the state commissioner of highways, and be built of steel or iron not less than eighteen feet wide upon masonry piers and abutments, upon plans of a competent bridge engineer, to be approved by the state commissioner of highways, and that said bridge shall be completed, opened to the public and accepted by the governor and council before the last installment, above provided for, shall be paid. All moneys under this resolve shall be paid upon vouchers satisfactory to the governor and council.

Proviso.

**CHAP. 190**

Towns may  
raise  
money.

The towns of Millinocket, East Millinocket and Medway are hereby authorized to raise money by loan, taxation or otherwise, to aid in the building of said bridge, and the county of Penobscot is hereby authorized through its commissioners to aid in the building of said bridge to such amount as said commissioners may deem expedient and to raise money by loan or taxation for said purpose.

**Chapter 190.**

Resolve in relation to the early York County Deeds.

Resolved, that E. C. Bowler, agreeing to supervise the copying, attesting, editing, indexing and publishing of volumes seventeen and eighteen of the public records of this state in the registry of deeds for York county, in the same manner as volumes fifteen and sixteen, published under the resolve approved January twenty-nine, nineteen hundred and seven, the governor and council shall purchase for the state four hundred and fifty copies of each said volumes at four dollars and twenty-five cents per volume; and the state librarian shall cause one copy of each volume to be placed in each registry of deeds in this state, and the remaining copies to be distributed or exchanged at the discretion of said librarian.

**Chapter 191.**

Resolve in favor of the town of Rumford.

Resolved, that the sum of six hundred forty-two dollars and sixty-seven cents, be and hereby is appropriated to be paid to the treasurer of the town of Rumford to reimburse said town of Rumford for money expended for the support of state paupers, namely: For the support of Benjamin Lord, four hundred twenty-seven dollars and eighty-five cents, for the year nineteen hundred and five; for the support of Joe Croteau, two hundred fourteen dollars and eighty-two cents, for the years nineteen hundred two and three.
