CHAP. 241.**Chapter 241.**

Resolve in favor of the County Commissioners of Franklin County, for the repair and permanent improvement of the road from Madrid line through Letter E Plantation and Sandy River Plantation.

Resolved, that the sum of seven hundred and fifty dollars be and is hereby appropriated for the repair and permanent improvement of the road leading from Madrid line through Letter E plantation and Sandy River plantation, to the old original highway from Phillips to Rangeley in Franklin county; the same to be drawn by and expended under the direction of the county commissioners of Franklin county.

Chapter 242.

Resolve authorizing the Land Agent to make a Deed for the purpose of curing defects in the title to Dog Fish Island in the Penobscot Bay.

Resolved, that the state land agent be, and hereby is authorized and empowered, upon payment of nominal consideration of one dollar, to make, execute and deliver to Lloyd H. Mills, his heirs and assigns, all the right, title and interest which the state of Maine has in and to Dog Fish island, located in Penobscot bay near the western entrance to Fox island thoroughfare, together with the adjacent, connected and outlying rocks and reefs to low water mark.

Chapter 243.

Resolve in favor of a monument for the late Commodore Samuel Tucker at Bremen, Maine.

Resolved, that the sum of one thousand dollars be and hereby is appropriated to be expended during the year one thousand nine hundred and nine, for the purpose of erecting a monument in the Bremen town cemetery at Bremen, Maine, to perpetuate the memory of the late Commodore Samuel Tucker, who commanded the armed schooners Franklyn and Hancock and the frigate Boston in the war of the revolution by commissions from George Washington. This appropriation shall be expended under the direction of a commission to consist of the governor and two other members, said two commissioners to be appointed

by the governor. The monument shall be cared for and kept in repair without expense to the state. Said commission shall complete their work and make report to the governor and council on or before December thirty-one, one thousand nine hundred and ten.

Chapter 244.

Resolve for the publication of the Railroad Map of Maine.

Resolved, that the sum of two hundred dollars be, and hereby is appropriated for the publication of the new edition of the railroad map of Maine to be distributed by the messengers pro rata to the members of the legislature for their use and distribution.

Resolve in favor of Road from town of Brownville to Katahdin Iron Works.

Resolved, that the sum of five hundred dollars be appropriated for the repair of road from the town of Brownville to Katahdin Iron Works, said sum to be expended under the direction of the county commissioners.

Chapter 246.

Resolve in favor of the town of Dover.

Resolved, that the sum of sixty-six dollars and thirty-three cents be, and is hereby appropriated for the purpose of reimbursing the town of Dover for money paid on account of Mrs. Joseph A. Tardiff, a state pauper.
