CHAP. 56

Chapter 56.

An Act to provide for the better preservation of Township Plans.

Be it enacted by the People of the State of Maine, as follows:

Chapter 11,
R. S.,
amended.

Chapter eleven of the revised statutes, relating to register of deeds is hereby amended by adding thereto the following section.

Plans show-
ing allot-
ment of lands
in cities and
towns, re-
cording of.

'Section 20. The aldermen of cities and the selectmen of towns may cause any plans in the possession of said cities or towns or otherwise available, showing the allotment of lands in said cities or towns, to be recorded in the registry of deeds in and for the county wherein any such city or town may be situated. Said plans to be transcribed or copied upon the best quality mounted drawing paper in a suitable book furnished by the register at the expense of the county.

officers shall
cause plans
to be re-
corded.

Said aldermen or selectmen shall on the written request of three or more freeholders of any such city or town, cause such plans to be recorded as herein provided. The register shall certify the record or copy of said plan for which he shall receive a fee of fifty cents to be paid by the city or town presenting such plan for record. Said city or town shall also pay in addition to the above the cost of copying or transcribing said plan on the record.'

Chapter 57.

An Act to regulate the Fees for Sealing Milk Bottles.

Be it enacted by the People of the State of Maine, as follows:

Section 21,
chapter 117,
R. S.,
amended.

Section twenty-one of chapter one hundred and seventeen of the revised statutes is hereby amended as follows: In line forty-two of said section, after the words "milk bottles", by striking out the words "three cents each", and writing in lieu thereof the following: 'in lots of one gross or less, one cent each, in lots from one to two gross, three-fourths of a cent each, in lots of more than two gross and not over four gross, one-half cent each, in lots greater than four gross, one-fourth of a cent each.'
