CHAP. 100

Chapter 100.

An Act to repeal Chapter three hundred and ninety-eight of the Private and Special Laws of nineteen hundred and nine relating to Fishing in Royal's River.

Be it enacted by the People of the State of Maine, as follows:

Chapter three hundred and ninety-eight of the private and special laws of nineteen hundred and nine is hereby repealed.

Chapter 101.

An Act to amend certain Acts relating to the Phillips Village Corporation.

Be it enacted by the People of the State of Maine, as follows:

Section 2,
chapter 141,
special laws
1887, as
amended by
chapter 73,
special laws
1891, further
amended.

Section 1. Section two of chapter one hundred and forty-one of the private and special laws of eighteen hundred and eighty-seven as amended by chapter seventy-three of the private and special laws of eighteen hundred and ninety-one is hereby further amended by striking out the word "legal" and the words "called for the purpose" in the second line of said section and inserting in place of the word "legal" the word 'annual' and by adding after the word "meeting" the following: 'provided such purpose is specified in a distinct article or articles inserted in the warrant or call for said meeting,' so that said section as amended shall read as follows:

for hydrants,
fire engines,
etc.

'Section 2. Said corporation is hereby invested with power at any annual meeting, provided such purpose is specified in a distinct article or articles inserted in the warrant or call for said meeting, to raise such sums of money as may be sufficient for the support of a suitable number of hydrants, in case water is brought into its limits in a suitable manner and sufficient quality, and suitable fire engines, engine houses, hose, buckets, hooks and ladders, and provide a sufficient quantity of water in the different parts of said corporation for the extinguishment of fire, and for organizing and maintaining within its limits a sufficient fire department; and to erect and maintain lamp posts and lamps and provide for lighting the streets within the limits of said corporation, and to make contracts with any persons or corporations for said purposes, and it may authorize its assessors to make such contracts, which shall be binding on said corporation and no money shall be raised for any other purpose except as above specified.'

CHAP. 102

Section 2. Section twelve of chapter one hundred and sixty-two of the private and special laws of nineteen hundred and five is hereby amended by striking out the word "legal" in the first line of said section and the words "called for that purpose" in the second line of said section and inserting in place of the word "legal" the word 'annual' and by adding after the word "meeting" the following: 'provided such purpose is specified in a distinct article or articles inserted in the warrant or call for said meeting,' so that said section as amended shall read as follows:

Section 12, chapter 162, special laws 1905, amended.

'Section 12. Said Phillips Village Corporation at any annual meeting, provided such purpose is specified in a distinct article or articles inserted in the warrant or call for said meeting, may vote to purchase the entire works and rights of the Phillips Water Company for such sums of money as may be adjudged payable according to the terms of article ten of the contract entered into between said Phillips Village Corporation and said Phillips Water Company. Or in accordance with the terms of any other contract hereinafter entered into by the same parties. Said Phillips Village Corporation shall, after said vote, and payment of the purchase price to said Phillips Water Company, receive from said Phillips Water Company an assignment and transfer of all the works and rights of said Phillips Water Company. And shall thereafter own and operate said works and exercise and enjoy the rights and franchise of said water company as fully as if granted to it direct.'

Chapter 102.

An Act to repeal Chapter one hundred and thirty-seven of the Private and Special Laws of nineteen hundred and three relating to the charter of the City of Auburn and the creation of the Board of Public Works.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Chapter one hundred and thirty-seven of the private and special laws of nineteen hundred and three is hereby repealed.

Certain act repealed.

Section 2. This act shall take effect provided a majority of the persons voting at a special election to be held in the city of Auburn on the second Monday in September nineteen hundred and eleven shall so determine.

When act shall take effect.
