Paupers.

Section 5. The persons hereafter becoming chargeable as paupers within the limits of said town shall be chargeable to said town of Eagle Lake, excepting those who are now state paupers.

Approved March 16, 1911.

Chapter 116.

An Act to repeal Chapter three hundred and eighty-two of the Private and Special Laws of nineteen hundred and seven relating to fishing in Wesserunsett Stream and tributaries, in the County of Somerset.

Be it enacted by the People of the State of Maine, as follows:

Fishing in Wesserunsett stream and tributaries, regulated.

Chapter three hundred and eighty-two of the private and special laws of nineteen hundred and seven relating to fishing in Wesserunsett stream and tributaries, in the county of Somerset, is hereby repealed.

Approved March 16, 1911.

#### Chapter 117.

An Act to authorize the removal of the bodies of deceased persons from the old cemetery in the Plantation of Elliottsville.

Be it enacted by the People of the State of Maine, as follows:

Removal of remains of deceased persons authorized.

---selection of new cemetery.

-expenses, by whom paid,

Greenville Light and Power Company is hereby empowered to authorize the assessors of the plantation of Elliottsville to take up from the old cemetery in the plantation of Elliottsville near the west bank of Wilson river the bodies and remains of all deceased persons buried therein, and all head stones and markers at the graves therein, and remove said bodies and remains to a new cemetery to be selected by said assessors and there decently inter the same, and properly re-set such head stones and markers over such dead bodies and remains. Said assessors are within thirty days after being requested in writing by said Greenville Light and Power Company to select the place for said new cemetery. If said assessors fail to locate said new cemetery and fix the bounds thereof within said thirty days, then the directors of said Greenville Light and Power Company are authorized to locate said cemetery in such place as will be suitable and most convenient for all of the inhabitants of said plantation. All of the expenses incurred in procuring the land necessary for said new cemetery in clearing and fitting the ground and in fencing said cemetery and in the taking up and removal of all of the remains of all of the deceased, persons, and in the removal of said head stones and markers, and

Снар. 118 the interment of said remains and re-setting of said head stones and markers shall be paid by the Greenville Light and Power Company.

No claim shall be made against said Greenville Light and No claim at-Power Company for not complying with the terms herein set days. out unless the same is made within sixty days after the Greenville Light and Power Company gives said assessors written notice that it has performed its duties under this act.

#### Chapter 118.

An Act to authorize the Mayor of the City of Portland to appoint Commissioners of Cemeteries and Public Grounds.

Be it enacted by the People of the State of Maine, as follows:

Section I. The mayor of the city of Portland is hereby Appointment ٥Î authorized and empowered to appoint a commission to be called sion. the commission of cemeteries and public grounds.

Section 2. The said commission shall consist of four per- Commission , sons and no more; the mayor of the city of Portland shall be tuted. chairman of the said commission ex-officio and shall constitute the fourth person of the said commission. The present three members of the said commission shall continue to hold office until the expiration of their terms, and as their terms expire the mayor shall appoint a member in the place of each respectively for three years, and in case of a vacancy he shall appoint a member for the unexpired term.

Section 3. Said commissioners shall have charge and con- Powers and trol of the department of forestry, city playgrounds, and of all duties of commission. cemeteries-other than Evergreen cemetery-together with parks, promenades, squares and trees on public streets and public grounds, which are, or may be hereafter reserved for ornamental use, belonging to the city of Portland, and under their direction all appropriations made for said cemeteries and grounds shall be expended for their proper care, including extermination of brown-tail and gipsy moths or any other pest. Said commis- \_\_may sioners are authorized to elect annually a superintendent, who superintendent. may be one of their number and who shall perform such duties as the commissioners prescribe. Said superintendent shall be paid monthly a salary fixed by the members of the said commission. The salary of the said superintendent to be taken -salary of from fund provided for in this act.
