or any of them, shall be entitled to the benefit of the provisions of section thirty-one of chapter forty-seven revised statutes or may be dissolved according to law.

Section 7. All duties and obligations public or private of any of the companies named in this act now or hereafter acquired by said Central Maine Power Company shall be assumed, performed and discharged according to the true intent and purpose thereof by said Central Maine Power Company which shall be subject to all appropriate suits and processes to enforce the same.

All bonds, securities or other obligations of like character issued by any of said companies shall be paid, performed or otherwise discharged as the case may require as the same fall due and shall be cancelled, discharged or otherwise retired and not re-issued.

All certificates of stock or other evidences of share capital of any of said companies coming into the ownership of said Central Maine Power Company free from liens or incumbrances shall be cancelled and retired as soon as the property of the company issuing such certificates or other evidences of share capital has been acquired by said Central Maine Power Company and shall not again be re-issued. Provided, however, that not exceeding ten shares of the capital stock of each or any of the corporations named above may be retained for the purpose of maintaining the organization of such corporation if for any reason it is found necessary.

Chapter 289.

An Act to appropriate moneys for the expenditures of government for the year one thousand nine hundred and eleven.

Preamble.

Expenditures of government, 1911,

in part.

Whereas, the appropriation of moneys for the maintenance of the several branches of the state government and its institutions is an emergency measure immediately necessary for the preservation of the public peace, health or safety, now therefore,

Be it enacted by the People of the State of Maine, as follows:

Section 1. In order to provide for the several acts and resolves of the legislature requiring the payment of money from the state treasury, and also to provide in part for the necessary expenditures of government, for the current fiscal year one thousand nine hundred and cleven, the following sums are hereby appropriated out of any moneys in the state treasury, and, except where otherwise specially provided, the governor with the advice and consent of the council, is hereby authorized at any time prior to the first day of July, one thousand nine hundred and twelve, to draw his warrant on the state treasurer for the same.

Chapter 290.

An Act to incorporate the Rumford and Mexico Water District. Be it enacted by the People of the State of Maine, as follows:

Section I. The following territory and the people within Corporate the same, namely; that part of the town of Rumford described and known as the Rumford Falls Village Corporation and such additions as may be made to it from time to time and that part of the town of Mexico herein designated, to wit., commencing at a point on the Androscoggin river where Swift river empties into the same on the dividing line between Rumford and Mexico; thence up the river by the dividing line between Rumford and Mexico on the westerly bank of Swift river on the Mexico side to a point on the westerly bank of Swift river directly opposite the northerly line of land formerly owned by H. W. Park and now owned by Frank Beaudett; thence at about right angles by said northerly line of said land formerly owned by said Park and now owned by said Beaudett and Roxbury road, so-called, to the westerly limits of the Thompson Hill road, so-called; thence up the hill by the northerly limits of said Thompson Hill road to a point within twenty feet of the place where the pipe line of the Mexico Water Company crosses this Thompson Hill road; thence up the hill in a line twenty feet northerly of said pipe line to a point on the westerly side of said Thompson Hill road directly opposite the northerly or easterly end of the dam of the Mex-
