**Chapter 44.**

Resolve in favor of the Children's Heart Work Society of Maine.

Resolved, that there be and hereby is appropriated the sum of three hundred dollars to be paid to the Children's Heart Work Society of Maine for the use of said society for the year nineteen hundred and eleven and three hundred dollars for the use of said society for the year nineteen hundred and twelve.

Resolve in favor of the Healy Asylum located at Lewiston.

**Chapter 46.**

Resolve in favor of the Maine Mission for the Deaf.

Resolved, that the sum of two hundred dollars be appropriated for the year nineteen hundred and eleven and two hundred dollars for the year nineteen hundred and twelve to aid in carrying out the purpose of the Maine Mission for the Deaf, and to aid in the support of the aged and infirm deaf of the state of Maine.
