CHAP. 52**Chapter 52.**

Resolve in favor of the Children's Protective Society of Portland.

Resolved, that the sum of five hundred dollars for the year nineteen hundred and eleven and five hundred dollars for the year nineteen hundred and twelve be and hereby is appropriated to be paid the Children's Protective Society of Portland, to assist the said society in its work in the protection and care of dependent and neglected children.

**Chapter 53.**

Resolve in favor of the Holy Innocents's Home for Infants in the city of Portland.

Resolved, that there be and is hereby appropriated the sum of four thousand dollars to be paid to the Holy Innocents' Home of Portland, for the use of the said institution; two thousand dollars to be appropriated for the use of said institution for the year nineteen hundred and eleven, and two thousand dollars to be appropriated for the use of the institution for the year nineteen hundred and twelve, for maintenance.

**Chapter 54.**

Resolve in favor of the Central Maine General Hospital in Lewiston.
