## CHAP. 85

**Chapter 85.**

Resolve in favor of Frank W. Buckman, Secretary of the Commission of Pharmacy.

Frank W.

Resolved, that there be and hereby is appropriated out of any funds of the state not otherwise appropriated the sum of eleven hundred and fifty-six dollars and forty-three cents, to be paid to Frank W. Buckman, secretary of the commission of pharmacy, for the benefit of said commission and to make up the deficiency incurred by said commission during the year nineteen hundred and ten.

Approved March 18, 1911.

**Chapter 86.**

Resolve in favor of the Lewiston and Auburn Children's Home.

Resolved, that there be and is hereby appropriated for the benefit, support, and maintenance of the Lewiston and Auburn Children's Home, a corporation existing in Lewiston, the sum of five hundred dollars for the year nineteen hundred and eleven, and the further sum of five hundred dollars for the year nineteen hundred and twelve.

Approved March 18, 1911.

**Chapter 87.**

Resolve in favor of Bangor Children's Home.

Resolved, that the sum of one thousand dollars be and hereby is appropriated in aid of the Bangor Children's Home, of Bangor, Maine, for the year nineteen hundred and eleven, and the sum of one thousand dollars for the year nineteen hundred and twelve for maintenance of said home.

**Chapter 88.**

Resolve in favor of Northern Maine General Hospital.

Resolved, that there be and hereby is appropriated the sum of two thousand dollars for the use of the Northern Maine General Hospital of Eagle Lake for the year nineteen hundred and eleven, and two thousand dollars for the year nineteen hundred and twelve for the maintenance of said hospital.
