Chapter 110.**CHAP. 110**

Resolve in favor of Harvard C. Jordan, of Ellsworth.

Resolved, that the sum of one hundred and fifty dollars be and hereby is appropriated to be paid to Harvard C. Jordan of Ellsworth for the expenses incurred by him in the seventy-fifth legislature, in contesting the seat of J. A. Peters of Ellsworth in the house of representatives.

Chapter 111.

Resolve in favor of Harry Stetson.

Resolved, that there be paid to Harry Stetson, secretary of joint special committee appointed to investigate the present financial condition of the state, the sum of four hundred and fifteen dollars for expenses incurred by him in connection with the hearings of the committee.

Chapter 112.

Resolve in favor of Otis Littlefield and Others.

Resolved, that the sum of one hundred and twenty-five dollars be and hereby is appropriated to be paid Otis Littlefield of Bluehill, ten dollars to be paid J. H. Webster of Ellsworth, twenty dollars to be paid Eben H. King of Lamoine, twenty dollars to be paid T. A. Crabtree of Hancock, twenty-five dollars to be paid Charles Green of Bluehill, severally for expenses incurred by them in connection with the contested election case of Otis Littlefield vs. Frank L. Hodgkins for representative to the seventy-fifth legislature from the class towns of Bluehill, Surry, Hancock, Trenton and Lamoine.

Chapter 113.

Resolve in favor of Rose J. Bubier of Lewiston.

Resolved, that there be paid to Rose J. Bubier, widow of the late John D. Bubier of Lewiston, Me., the sum of eight dollars per month, payable quarterly from the fund appropriated for military pensions, and to begin April first, nineteen hundred and eleven.
