**CHAP. 123****Chapter 123.**

Resolve in favor of the town of Phippsburg to correct error in the apportionment of School and Mill Fund of nineteen hundred and eight.

Resolved, that the sum of three hundred and eighty dollars and seventy-three cents be and is hereby appropriated out of the school and mill fund of nineteen hundred and eleven to be paid to the town of Phippsburg to correct error in the amount of the school and mill fund apportioned to the town of Phippsburg in the year nineteen hundred and eight.

**Chapter 124.**

Resolve in Favor of the Sagadahoc Agricultural and Horticultural Society.

Resolved, that the sum of twelve hundred and eight dollars and forty-seven cents be and hereby is appropriated, to be paid to the Sagadahoc Agricultural and Horticultural Society, same being the amount of the state stipend apportioned and due to said society for the year nineteen hundred and eight.

**Chapter 125.**

Resolve in favor of the Maine Insane Hospital.

Resolved, that there be and hereby is appropriated the sum of one hundred ninety-two thousand three hundred dollars for the year nineteen hundred and eleven, for the use of the Maine insane hospital. For the full support of all state charges for the year nineteen hundred and eleven.

**Chapter 126.**

Resolve in favor of maintaining Lights and Buoys on Upper and Lower Richardson Lakes.

Resolve, that the sum of fifty dollars be and is hereby appropriated for the year nineteen hundred and eleven, also fifty dollars for the year nineteen hundred and twelve, to be expended under the direction of the steamboat inspectors, for maintaining lights on the buoys in upper and lower Richardson lakes.
