CHAP. 226

Sixth: Penobscot, 1913, 1914, 1917, 1918, 1919, 1920, 1921, 1922; Piscataquis, 1915, 1916.

Seventh: Aroostook, 1913, 1914, 1919, 1920, 1921, 1922; Washington, 1915, 1916, 1917, 1918.

Approved March 31, 1911.

Chapter 226.

Resolve, to apportion one hundred and fifty-one representatives among the several counties, cities, towns, plantations and classes in the State of Maine.

Apportionment of representatives, resolve for.

Resolved, that for the seventy-sixth legislature to and including that of the year nineteen hundred and twenty-one:

The county of Androscoggin shall choose twelve representatives to be apportioned as follows: Lewiston, five representatives; Auburn, three representatives; Lisbon, one representative; Poland, Mechanic Falls, Greene and Leeds, one representative; East Livermore, Livermore and Turner, one representative; Webster, Wales, Durham and Minot one representative.

The county of Aroostook shall choose fifteen representatives to be apportioned as follows: Hersey, Island Falls, Crystal, Sherman, Benedicta, Silver Ridge, Molunkus, Macwahoc, three, range four, two, range four, one, range four and one, range five, one representative; Linneus, Hodgdon, Cary, A, range two, Leavitt, Amity, three, range three, Glenwood, Haynesville, Orient, Weston, Bancroft, Reed, and four, range three, one representative; Houlton, one representative; Dyer Brook, Oakfield, Moro, Merrill, Smyrna, Limerick, Ludlow, Hammond, Littleton, seven, range three, seven, range four, seven, range five, eight, range three, eight, range four and eight, range five, one representative; Monticello, Bridgewater, Blaine, Mars Hill, C plantation, D plantation and E plantation, one representative; Easton, Westfield, Chapman, Mapleton, Washburn, nine, range three, and ten, range three, one representative; Presque Isle, one representative; Fort Fairfield, one representative; Caribou, one representative; Limestone, Caswell, Connor, New Sweden, Westmanland, Stockholm, Woodland, and sixteen, range four, one representative; Van Buren, Hamlin, Cyr, Grand Isle, seventeen, range three, one representative; Frenchville, St. Agatha and Madawaska, one representative; Fort Kent and Wallagrass, one representative; Eagle Lake, Hill, Allagash, St. Francis, St. John, New Canada, seventeen, range four, seventeen, range five, sixteen, range five, fifteen, range six, fourteen, range

six, and all other unorganized townships, one representative; Ashland, Garfield, Nashville, Portage Lake, Perham, Wade, Castle Hill, Masardis, Oxbow, nine, range four, ten, range four, ten, range six, eleven, range four, nine, range five, twelve, range five, thirteen, range five and fourteen, range five, one representative.

The county of Cumberland shall choose twenty-three representatives to be apportioned as follows: Portland, seven representatives; Westbrook, two representatives; Brunswick, two representatives; Bridgton, one representative; Gorham, one representative; Pownal and Freeport, one representative; Cumberland and Falmouth, one representative; Scarborough and Cape Elizabeth, one representative; South Portland, two representatives; Baldwin, Sebago and Standish, one representative; Harrison, Otisfield and Windham, one representative; Gray, Raymond and New Gloucester, one representative; Harpswell, Casco and Naples, one representative; North Yarmouth for the year nineteen hundred and thirteen, one representative; Yarmouth for the years nineteen hundred and fifteen, nineteen hundred and seventeen, nineteen hundred and nineteen and nineteen hundred and twenty-one, one representative.

The county of Franklin shall choose four representatives to be apportioned as follows: Wilton, Jay and Carthage, one representative; Farmington, Chesterville, Temple, Washington and Perkins plantation, one representative; Phillips, Avon, Strong, New Vineyard, Industry, New Sharon, Township B, Township E, Township number six and Weld, one representative; Freeman, Salem, Kingfield, Madrid, Rangeley, Eustis, Long plantation, Coplin plantation, Dallas plantation, Sandy River plantation, Rangeley plantation, and all other territory not included in any other district, one representative.

The county of Hancock shall choose seven representatives to be apportioned as follows: Eden, one representative; Bucksport, Orland, Castine, Dedham and Verona, one representative; Ellsworth, Trenton, Aurora, Amherst, Otis, Mariaville, Waltham and Township eight, ten, twenty-one, twenty-eight, thirty-three, one representative; Stonington, Deer Isle, Sedgwick, Isle au Haut, Eagle Island, Hog Island, Butter Island, Bear Island, Pumpkin Island and Long Island, one representative; Gouldsboro, Sullivan, Franklin, Hancock, Winter Harbor, Sorrento, Eastbrook and townships seven and nine, one representative; Bluehill, Surry, Brooklin, Penobscot and Brooksville, one representative; Mt. Desert, Tremont, Southwest Harbor, Swan's Island, Cranberry Island, Lamoine, Mt. Desert Rock and Marshall's Island, one representative.

The county of Kennebec shall choose thirteen representatives to be apportioned as follows: Augusta, two representatives; Waterville, two representatives; Gardiner, one representative; Clinton, Albion, Benton, Unity plantation, one representative; Winslow, Vassalboro, one representative; Chelsea and Farmingdale, one representative; Windsor, Randolph, Pittston and China, one representative; Hallowell, West Gardiner and Manchester, one representative; Monmouth, Litchfield and Winthrop, one representative; Wayne, Readfield, Mount Vernon, Fayette, Vienna and Rome, one representative; Oakland, Belgrade and Sidney, one representative.

The county of Knox shall choose six representatives to be apportioned as follows: Rockland, one representative; Camden, Hope and Washington, one representative; Rockport, Warren and North Haven, one representative; Union, Appleton and Thomaston, one representative; Cushing, Friendship, Vinalhaven, Matinicus and Criehaven, one representative; St. George, South Thomaston, Muscle Ridge and Hurricane Isle, one representative.

The county of Lincoln shall choose four representatives to be apportioned as follows: Wiscasset, Dresden, Whitefield, Jefferson and Somerville, one representative; Waldoboro, Damariscotta, Nobleboro and Bremen, one representative; Boothbay, Edgecomb, New Castle, Alna, Southport and Westport, one representative; Boothbay Harbor, Bristol, and Monhegan, one representative.

The county of Oxford shall choose seven representatives to be apportioned as follows: Rumford, one representative; Oxford, Norway and Waterford, one representative; Hebron, Paris and Woodstock, one representative; Dixfield, Peru, Canton, Hartford, Sumner and Buckfield, one representative; Hiram, Porter, Denmark, Brownfield, Fryeburg and Stow, one representative; Gilead, Riley, Newry, Grafton, Upton, Magalloway, Lincoln, Andover, Byron, Roxbury and Mexico, one representative; Lovell, Sweden, Stoneham, Albany, Greenwood, Milton, Mason, Bethel, Hanover and all other unclassified territory, one representative.

The county of Penobscot shall choose seventeen representatives to be apportioned as follows: Bangor, four representatives; Brewer, one representative; Old Town, one representative; Dexter and Garland, one representative; Corinna, Newport, Dixmont and Etna, one representative; Plymouth, Newburgh, Carmel, Stetson, Exeter, Levant, one representative; Charleston, Corinth, Hudson, Kenduskeag, Bradford, Glenburn

and Alton, one representative; Hampden, Hermon, and Veazie, one representative; Orono and Bradley, one representative; Orrington, Holden, Clifton, Eddington, Milford, Greenfield, Greenbush and Argyle, one representative; Lincoln, Lee, Springfield, Carroll, Burlington, Lakeville, Webster and township number five, range one, N. B. P. P., and township number three, range one, N. B. P. P., one representative; Millinocket, East Millinocket, Indian Township Three, Indian Township Four, Township A and Township A West and Hopkins Academy Grant, one representative; Lagrange, Edinburg, Howland, Maxfield, Passadumkeag, Lowell, Grand Falls, Seboeis, Summit, Enfield, Mattamiscontis, Chester and Winn, one representative; Patten, Mt. Chase, Stacyville, Medway, Woodville, Mattawamkeag, Kingman, Drew, Prentiss and all other unclassified territory, one representative.

The county of Piscataquis shall choose four representatives to be apportioned as follows: Greenville, Shirley, Blanchard, Kingsbury, Wellington, Elliottsville, Monson, Willimantic and all territory not otherwise classified, one representative; Parkman, Sangerville, Guilford, Abbot, Bowerbank, Williamsburg, Barnard and Katahdin Iron Works, one representative; Dover, Foxcroft, Atkinson and Sebec, one representative; Orneville, Milo, Medford, Brownville and Lakeview, one representative.

The county of Sagadahoc shall choose four representatives to be apportioned as follows: Bath, two representatives; Perkins, Topsham, Richmond, and Georgetown, one representative; Arrowsic, Bowdoin, Bowdoinham, Phippsburg, Woolwich and West Bath, one representative.

The county of Somerset shall choose seven representatives to be apportioned as follows: Skowhegan, one representative; Fairfield, Smithfield, and Mercer, one representative; Pittsfield, Palmyra, Detroit and Cornville, one representative; Hartland, St. Albans, Ripley, Cambridge, Harmony and Canaan, one representative; Madison, Solon and Athens, one representative; Norridgewock, Anson, Starks, Embden and Concord, one representative; Bingham, New Portland, Moscow, Bigelow, Brighton, Brighton plantation, Carratunk plantation, Dead River plantation, Dennistown plantation, Flagstaff plantation, Highland plantation; Jackman plantation, Lexington plantation, Mayfield plantation, Moose River plantation; Pleasant Ridge plantation, The Forks plantation and the West Forks plantation, one representative.

The county of Waldo shall choose five representatives to be apportioned as follows: Belfast, one representative; Unity,

Montville, Freedom, Troy, Burnham, Knox and Thorndike, one representative; Swanville, Searsport, Waldo, Monroe, Brooks, and Jackson, one representative; Lincolnville, Liberty, Sears-mont, Morrill, Palermo, Northport and Belmont, one representative; Stockton Springs, Islesboro, Prospect, Frankfort and Winterport, one representative.

The county of Washington shall choose nine representatives to be apportioned as follows: East Machias, Marion, plantation number fourteen, Dennysville, Edmunds, Crawford, Whiting, and Machiasport, one representative; Cooper, Perry, Alexander, Meddybemps, Charlotte, Robbinston, and Pembroke, one representative; Centerville, Whitneyville, Roque Bluffs, Northfield, Wesley, Machias, Marshfield and Jonesboro, one representative; Trescott, Lubec and Cutler, one representative; Eastport, one representative; Calais, one representative; Baileyville, Baring, plantation number thirty-one, Danforth, Brookton, Forest City, Talmadge, Topsfield, Vanceboro, Waite, Codyville, Grand Lake Stream, Princeton and all territory not otherwise classified, one representative; Milbridge, Steuben, Cherryfield, Beddington and Deblois, one representative; Addison, Columbia, Columbia Falls, Harrington and Jonesport, one representative.

The county of York shall choose fourteen representatives to be apportioned as follows: Biddeford, three representatives; Saco, one representative; Sanford, one representative; North Berwick and South Berwick, one representative; Kennebunk and Lyman, one representative; York and Wells, one representative; Berwick and Lebanon, one representative; Acton, Cornish, Newfield and Parsonsfield, one representative; Alfred, Limerick, Shapleigh and Waterboro, one representative; Buxton, Dayton, Hollis and Limington, one representative; Kennebunkport and Old Orchard, one representative; Eliot and Kittery, one representative.
