Chapter 6.

Resolve on the pay roll of the Senate.

Pay roll of the Senate, supplementary, in favor of.

Resolved, that there be paid out of the treasury of the state to the several persons named in the foregoing pay roll the sums set against their names respectively, amounting to the sum of four hundred sixty-one dollars.

Approved April 6, 1912.
