Chapter 31.

An Act Providing for the Free Treatment of Juvenile Dependents by Institutions Receiving State Aid.

Be it enacted by the People of the State of Maine, as follows:

Patients shall be received free from State School for Boys or Industrial School for Girls.

—superintendent shall certify to institution.

-proviso.

Section I. Any hospital, infirmary or institution in which patients are treated surgically or for disease, which shall receive an appropriation from the state shall, during the year for which such appropriation is made, in consideration thereof. receive as a patient therein any person committed to and under the control of the State School for Boys or Industrial School for Girls, whom the Superintendent of the State School for Boys or the Principal of the Industrial School for Girls shall certify to such institution in writing is in need of medical or surgical treatment, and shall furnish to such person therein proper food, lodging, medicine, surgery, medical attendance and nursing, so long as necessary, free of charge. Provided that all rules, regulations, customs and usages now existing or hereafter created in each such hospital, infirmary or institution in regard to admission, dismissal, treatment, conduct and all other matters shall apply equally and to the same extent to patients received under this act as to other patients at the same hospital, infirmary or institution; nothing in this act to the contrary notwithstanding.

Chapter 32.

An Act to Amend Section Twenty-two of Chapter Forty-eight of the Revised Statutes, Relating to Lost Bank Deposit Books.

Be it enacted by the People of the State of Maine, as follows:

Section 22, chapter 48, R. S., amended. Section I. Section twenty-two of chapter forty-eight of the revised statutes of Maine is hereby amended by inserting after the word "issued" in the first line of said section the words 'by any savings bank or by any trust company for a deposit in its savings department,' and by inserting the words 'or trust company' after the word "bank" where it occurs in the third and seventh lines of said section, so that said section as amended shall read as follows:

Duplicate book of deposit, how otbained in case of loss of original. 'Section 22. When the person, to whom a book of deposit was issued by any savings bank or by any trust company for a deposit in its savings department, or his executor, or administrator, or guardian, in writing notifies the treasurer of the
