#### Chapter 132.

Снар. 132

An Act in Relation to the Title to Islands Belonging to the State.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The title to all islands located in great ponds within the state of Maine, except such as have been previously granted away by the state, shall remain in the state of Maine and be reserved for public use.

Section 2. The title to all islands located in the sea within the jurisdiction of the state of Maine, except such as have been previously granted away by the state or are now held in private ownership, shall remain in the state of Maine and be reserved for public use.

Approved March 31, 1913.

Title to islands in ponds not previously granted shall remain in state of Maine.

Title to islands in sea not previously granted shall remain in state of Maine.

#### Chapter 133.

An Act Requiring Dealers to Register the Sale or Other Transfer of Fire Arms.

Be it enacted by the People of the State of Maine, as follows: Section 1. No dealer shall sell, let, or loan any firearm to any person without first recording in a book kept for the purpose, the name or make, calibre and number, if any, of said firearm, also the name and address of the purchaser or recipient of said firearm.

Record shall be kept of all fire-arms sold.

Said record shall be made before said firearm is delivered, and shall be open to the inspection of any sheriff, deputy sheriff, police officer, constable, game warden, or prosecuting attorney. Any dealer who fails to keep such a record or refuses to show the same to any officer, named above, shall be punished by a fine not exceeding fifty dollars. Whoever gives a false or fictitious name to said dealer shall be punished by a fine not exceeding fifty dollars.

Record shall be open for inspection.

—penalty for not keeping record.

—penalty for giving false name

Exceptions.

Section 2. The provisions of this act shall not apply to wholesalers, who sell only to other dealers or to manufacturers who sell only at wholesale.
