CHAP. 137

Steamboats on inland waters. 'Section 4. All vessels propelled by steam upon inland waters are subject to the following provisions; and before being so employed they shall be examined, and receive the certificate of the inspectors authorizing their employment. And all boats and vessels, propelled by gasoline, gas, petroleum in any form or electricity, and used for the transporting and carrying of passengers for hire upon the inland waters of this state, shall be subject to the provisions of this and the ten sections immediately following, excepting sections six and nine, and the application of said sections six and nine to this class of boats and vessels, shall be left to the discretion of the inspectors who may, if they deem it advisable, cause compliance with the same.'

#### Chapter 137.

An Act Additional to Chapter Eighty-four of the Revised Statutes, Relating to the Proceedings in Certain Civil Actions in Court.

Be it enacted by the People of the State of Maine, as follows:

Affidavit of plaintiff prima facie evidence Section 1. In all actions brought on an itemized account annexed to the writ, the affidavit of the plaintiff, made before a notary public using a seal, that the account on which the action is brought is a true statement of the indebtedness existing between the parties to the suit, with all proper credits given, and that the prices or items charged therein are just and reasonable, shall be prima facie evidence of the truth of the statement made in such affidavit, and shall entitle the plaintiff to the judgment, unless rebutted by competent and sufficient evidence.

When corporation is plaintiff.

Section 2. When the plaintiff is a corporation, in cases in which the provisions of the preceding section are applicable, the affidavit may be made by its president, secretary or treasurer.

#### Chapter 138.

An Act to Amend Sections Forty-one, Forty-two, Forty-three and Forty-four of Chapter Fifteen of the Revised Statutes, as Amended, Relating to the Employment of Superintendents of Towns Comprising School Unions.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section forty-one of chapter fifteen of the revised statutes, as amended by chapter one hundred one of the public laws of nineteen hundred seven and as amended by chap-
