Chapter 68.

An Act to Change the Name of Hayden Lake, So-called, to Wesserrunsett Lake.

Be it enacted by the People of the State of Maine, as follows:

Section I. That the name of the lake or pond heretofore known as Hayden Lake, and sometimes known as Madison Pond, the same being situated in the town of Madison in the county of Somerset, be, and the same hereby is, changed from Hayden Lake, to Wesserrunsett Lake.

Hayden Lake, name changed to Wesserruusett Lake.

Section 2. All acts or parts of acts inconsistent herewith are hereby repealed.

Chapter 69.

An Act to Authorize the Kingman Lumber Company to Build and Maintain Piers and Booms in the Mattawamkeag and Molunkus Rivers.

Be it enacted by the People of the State of Maine, as follows:

Section I. The Kingman Lumber Company, a corporation organized and existing under the laws of Maine, its successors and assigns, are hereby authorized and empowered to locate, erect and maintain in the Mattawamkeag river between a point opposite the station of the Maine Central railroad in Kingman, and the mouth of the Molunkus river on said river in said town of Kingman in the county of Penobscot, piers and booms for the purpose of collecting, holding, sorting and storing logs and other lumber in said Mattawamkeag river, that belong to said company or may be intended for use, shipment, sale or manufacture at the mills of said company.

Section 2. Said Kingman Lumber Company is hereby authorized and empowered to maintain holding booms extending from the foot of Oxbow island in the Molunkus stream to the head of said island occupying the west channel of said Oxbow and also a holding boom extending across the mouth of the Webster lagoon or cove on the west side of said Molunkus stream for the purpose of collecting, holding, sorting and storing logs and other lumber in said Molunkus stream that belong

to said company or may be intended for use, shipment, sale or manufacture at the mills of said company.

Piers and booms shall not unreasonably obstruct common use of said rivers. Section 3. Said piers and booms shall be so located, constructed, used and maintained as not to unreasonably obstruct the common use of said Mattawamkeag and Molunkus rivers, or to unreasonably delay logs or lumber coming or being driven down said rivers and destined for use, manufacture, shipment or sale at points below the mills of said lumber company.

The company may collect, hold, sort and store its logs, etc., from logs of other persons.

Section 4. Said Kingman Lumber Company, its successors and assigns, are hereby authorized and empowered to collect, hold, sort and store logs and other lumber owned by said Kingman Lumber Company, or destined for use, sale, manufacture or shipment at the mills of said Kingman Lumber Company, by, with and at said piers and booms from all logs and other lumber in said Mattawamkeag and Molunkus rivers, owned by other parties and destined for use, manufacture or sale at points other than the mills of said company, and said company is also authorized and empowered to hold within the piers and booms mentioned in this act all logs and other lumber coming down either of said rivers, which are destined or intended for use, sale, manufacture or shipment at the mills of said company.

Collecting, holding, sorting and storing its logs, etc., shall not unreasonably delay logs of other persons. Section 5. The collecting, holding, sorting and storing authorized in section four of this act shall be so managed, performed and done as not to unreasonably interfere with, obstruct or delay logs or lumber of other parties destined for other points than the mills of the said Kingman Lumber Company. All sorting authorized by this act shall be done at the sole charge and expense of said Kingman Lumber Company and any log owner whose logs shall be sorted by said Kingman Lumber Company shall have the right to appoint an agent to see that said sorting is properly done and the reasonable expense of said agent shall be paid by the said Kingman Lumber Company, its successors and assigns.

Chapter 70.

An Act to Repeal Chapter Three Hundred and Thirty-seven of the Private and Special Laws of Eighteen Hundred and Twenty-five, Entitled "An Act for the Peservation of Fish in Piscataqua River."

Be it enacted by the People of the State of Maine, as follows:

Chapter 337 of P. & S. laws of 1825 repealed. Section I. Chapter three hundred and thirty-seven of the private and special laws of eighteen hundred and twenty-five entitled, "An act for the preservation of fish in Piscataqua river is hereby repealed."
