CHAP. 101

May prepare an index.

Expense of making and indexing, how paid.

Copies duly attested shall have same force as originals.

Said county commissioners are further authorized and empowered to have prepared an index to said copy, if in their judgment, the same is necessary.

Section 2. The expense of making said copy and of filing and indexing the same, shall be paid from the treasury of Oxford county, upon bills audited by said county commissioners.

Section 3. Copies duly attested by the register of deeds for said Oxford county, western district, made from the copy herein authorized, attested and filed as aforesaid, shall be of the same force and effect as like copies made from the original records of said volume one.

Chapter 101.

An Act to Enlarge the Purposes of the Huse Spool and Bobbin Company.

Be it enacted by the People of the State of Maine, as follows:

Corporation authorized to sell electricity, light and power.

Section 1. The Huse Spool and Bobbin Company, a corporation organized under the general law and located and doing business at Kingfield, Maine, is hereby authorized to sell electricity, light and power, and do all things necessary to carry on the business of an electric light and power company within the limits of said town of Kingfield.

May own and operate telephone lines in Kingfield.

Section 2. Said company is also authorized to construct, maintain, lease, own and operate telephone lines within said town of Kingfield.

Reference to this act to be minute on original certificate.

Section 3. The secretary of state shall minute upon the record of the original certificate of incorporation in his office reference to this act, when the same becomes law.

Chapter 102.

An Act to Amend Chapter Five Hundred and Four of the Private and Special Laws of Eighteen Hundred Eighty-nine, Incorporating the Otter Creek Bridge Company.

Be it enacted by the People of the State of Maine, as follows:

Chapter 504 of the P. & S. laws of 1889, amended.

Section 1. Chapter five hundred and four of the private and special laws of eighteen hundred eighty-nine is hereby amended in the second section thereof by striking out the words "thirty-five" in the sixth line of said section and substituting therefor the words 'twenty-four' and by striking out the words "thirty-five" in the thirteenth line thereof and substituting the words

'twenty-four' so that said section as amended shall read as follows :

CHAP. 103

'Section 2. Said road and bridge shall be located at or near said Otter Creek Bar, and general continuation thereof, from Eden to Mount Desert, in a suitable and convenient place, and said road shall be built of earth, stone, wood or other good material, and of not more than four rods in width. Said bridge shall contain a draw, which shall be twenty-four feet in width, in the clear, and located to meet the needs of navigation at that point, and said company may build, erect and maintain such piers, abutments and other structures, as it may deem necessary in the premises, within and without said four rod limit. Said company is to so construct said bridge that there shall always be one hundred feet in the clear, including said twenty-four feet of draw, for the unobstructed influx and efflux of tide.'

Location of road and bridge.

—road shall be built of good material.

—bridge shall contain a draw.

—company may build piers, etc.

—shall be one hundred feet for flow of tide.

Section 2. The towns of Eden and Mt. Desert or either of them are hereby authorized to contribute such sums toward the cost of construction of said road and bridge as they may vote to contribute at any legal meeting of the inhabitants thereof.

Towns of Eden and Mt. Desert may contribute for construction.

Section 3. The organization of said corporation and the transfer of stock in the same by assignment from Caroline Wellington and Louise W. Peaslee, heirs of Cornelius Wellington, one of the corporators named in said act, and the holding of said stock, by the Otter Creek Realty Company, a corporation existing under the law of Maine and located at said Otter Creek, are hereby authorized and made valid.

Organization and other acts made valid.

Approved March 14, 1913.

### Chapter 103.

An Act to Amend Section Eight of Chapter Thirteen of the Private and Special Laws of Nineteen Hundred and Eleven, Entitled "An Act to Create the Bingham Water District."

*Be it enacted by the People of the State of Maine, as follows :*

Section eight of chapter thirteen of the private and special laws of nineteen hundred and eleven, is hereby amended by striking out all of said section eight, and inserting in place thereof the following :

Section 8 of chapter 13 of P. & S. laws of 1911, amended.

'Section 8. The trustees of said Bingham Water District are hereby authorized, whenever they deem it necessary for the welfare of the district, or for the purpose of raising funds to defray the expense of furnishing water in said district for the purpose of fire protection, or for the purpose of raising funds to be expended on repairs, alterations or additions to said district's water system, to levy a tax upon the legally taxable prop-

Trustees may levy tax on district.
