Use of automobiles in town of Islesboro

prohibited.

Penalty for violation of this act.

Chapter 105.

An Act to Prohibit the Use of Automobiles on Public Roads in the Town of Islesboro.

Be it enacted by the People of the State of Maine, as follows:

Section 1. No automobile or motor vehicle shall be set up, used, driven or operated in or on any highway, townway or public street within the town of Islesboro in the county of Waldo, and State of Maine.

Section 2. Whoever sets up, uses, drives or operates any automobile or motor vehicle contrary to the provisions of section one hereof, shall on first conviction be punished by a fine of twenty dollars and costs of prosecution, and on second and every subsequent conviction shall be punished by a fine of fifty dollars and costs of prosecution, or by imprisonment for not exceeding sixty days, or by both fine and imprisonment.

Chapter 106.

An Act to Make Valid the Organization of the Pepperrell Association of Kittery, Maine, Under Chapter Fifty-seven of the Revised Statutes, in the Year of Our Lord Eighteen Hundred and Ninety-seven.

Be it enacted by the People of the State of Maine, as follows:

The organization of the Pepperrell Association of Kittery, Maine, under chapter fifty-seven of the revised statutes, in the year of our Lord eighteen hundred and ninety-seven, is hereby made valid and all its past acts are hereby made valid and legal.

Chapter 107.

An Act to Amend Chapter Thirty of the Private and Special Laws of Nineteen Hundred Eleven, Authorizing the Wiscasset, Waterville and Farmington Railway Company to Dispose of a Part of the Property of Said Company.

Be it enacted by the People of the State of Maine, as follows:

Chapter thirty of the private and special laws of nineteen hundred eleven is hereby amended by adding thereto the following section.

'Section 4. Said Wiscasset, Waterville and Farmington Railway Company shall have a period of two years within which the
