Chapter 112.

Снар. 112

An Act to Amend the Charter and Extend the Rights of the Goodall Worsted Company.

Be it enacted by the People of the State of Maine, as follows:

Section r. The Goodall Worsted Company, a corporation existing under the general laws of the state of Maine, is hereby authorized and empowered to carry on the following business, in addition to those named in its certificate of organization, to wit:

Goodall Worsted Co., to grant additional powers to.

- 1. To manufacture, buy, sell and deal in wool and all animal and vegetable fibres and products.
- 2. To develop any water power now or hereafter owned by said company on the Mousam river, in the county of York, and acquire and maintain auxiliary power plants, for the purpose of making, generating, selling, distributing, or supplying electricity, for power or lighting purposes, to be used only in connection with the operation of its mills, storehouses and coal pockets or the use of concerns or individuals occupying its mills, storehouses and coal pockets, as tenants under lease.

To deal in wool and other fibres, etc.

To develop certain water powers and plants.

—to generate and supply electricity.

3. To purchase or otherwise acquire real estate, lumber or interests therein that may be beneficial to the company. To hold, develop, improve, sell or otherwise dispose of any lands or property belonging to the company or in which the company is interested.

To acquire real estate, etc.

4. To own and operate saw mills, and to manufacture lumber; to manufacture, mold and build machinery of all kinds of whatever material.

To do a general lumber business.

5. To own in whole or in part, or to operate, charter, hire, use and lease freight vessels of any description to carry on the business of freight upon the high seas, to or from any port or ports in Maine to any other domestic port or ports.

To acquire vessels and do a freight business.

6. To carry on any mercantile or other business incidental to the ownership, operation or development of its property or any that it may acquire.

To carry on mercantile or other business.

Section 2. Said company, for the purposes of this act, is hereby authorized to issue bonds from time to time, and to secure the same by appropriate mortgage of such of its property and franchise as its stockholders may vote at any annual or special meeting, providing the subject matter is fully stated in the call for the meeting.

May issue bonds.

Section 3. Said company is hereby authorized to set poles and wires thereon, in and through any street, road and way from its power plant or plants to its mill or mills, storehouses

May set ... poles and wires thereon.

—to its properties.

Chap. 113 and coal pockets, all subject to the same rights and liabilities incident to similar corporations as fixed by the general statutes relating thereto.

Chapter 113.

An Act to Incorporate the Pleasant Hill Cemetery Association in the Town of Webster.

Be it enacted by the People of the State of Maine, as follows:

Corpora-

Section 1. O. R. Jones, J. W. Maxwell, John F. Hirst, Joseph Thorpe, L. S. Libby, George Keates, Wm. M. Hall, W. F. Sanborn, C. H. Brewer, W. S. Maxwell, F. E. Sawyer, A. L. Bangs, C. L. Billings and John H. Wilkins, their associates and successors, are hereby made a corporation by the name of the Pleasant Hill Cemetery Association, for the purpose of acquiring, holding, controlling, caring for, and improving ground set apart and used for burial purposes, situated in said town of Webster on the easterly side of the county road leading from the residence of John McBride past the residence of E. A. Drinkwater to Wales, and bounded southwesterly and southeasterly by land of the said McBride and northeasterly by land of John McCarthy, known as the W. T. Kirby place, and said corporation shall have all the powers and privileges, and be subject to all the duties, restrictions and liabilities contained in the general laws existing or which may hereafter be in force relating to such corporation.

May assume control of burial place when duly conveyed.

Section 2. Said corporation is hereby authorized to take possession and assume legal control of the burial place aforesaid whenever the same shall have been duly conveyed to it by the person holding legal title to the same, and said corporation shall hold the land of, and all other property, rights and things appertaining to said burial place, for the same uses and purposes for which they are now held; and all rights which any persons have acquired therein shall remain valid to the same extent as if this act had not been passed.

May acquire other land.

-may hold personal property.

Section 3. Said corporation may acquire by purchase, gift or devise, and hold in fee additional or other land to the extent of four acres for the purpose of enlarging said cemetery from time to time or purchasing other land west of said road from time to time, and may hold such personal property as may be necessary for the purpose of the corporation; and said corporation is hereby authorized to take and hold any grant, donation or bequest of property upon trust, and to apply the same
