Chapter 196.

Снар. 196

An Act to Repeal Chapter Three Hundred Fifteen of the Private and Special Laws of Nineteen hundred Three, Entitled "An Act to Incorporate the Madunkeunk Dam and Improvement Company."

Be it enacted by the People of the State of Maine, as follows:

Chapter three hundred and fifteen of the private and special laws of the State of Maine, approved March twenty-sixth, nineteen hundred three, entitled "An Act to Incorporate the Madunkeunk Dam and Improvement Company," is hereby repealed.

Chapter 315 of P. & S. laws of 1903, repealed.

Approved March 31, 1913.

Chapter 197.

An Act to Amend Chapter Two Hundred Seventeen of the Private and Special Laws of Nineteen Hundred and Eleven, Increasing the Corporate Limits of the Porter Kezar Falls Village Corporation of Porter.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section one of said chapter is hereby amended as follows: By inserting after the word "at" in the eleventh line the following: 'Also the part of the territory of the town of Hiram in the county of Oxford embraced within the following described limits. Commencing at a point on the town line between the towns of Porter and Hiram twenty-five rods northerly of the county road leading through Kezar Falls village and South Hiram to Cornish village, thence easterly and parallel with said road and twenty-five rods therefrom to westerly line of land of Lewis Gould, thence southerly on said westerly line to said road and continuing the same course to the Great Ossipee river, thence westerly up said river to said town line, thence northerly on said town line to the point begun at,' so that when amended said section shall read as follows:

'Section I. The territory in town of Porter embraced within the following limits: Beginning at the Kezar Falls Woolen Co's. dam on the Great Ossipee river, thence northerly and parallel with School street in said Kezar Falls village to an open drain on southerly part of Wm. Chapman and Son's land about ten rods north of homestead of Irvin Mason; thence easterly and southerly by said drain and Spectacle pond brook to Hiram line; thence southerly on said Hiram line to Great Ossipee river; thence westerly on said river to first mentioned point begun at; also the part of the territory of the town of Hiram in the county of Oxford embraced within the following described limits: Commencing at a point on the town line between the towns of

Porter and Hiram, twenty-five rods northerly of the county road leading through Kezar Falls village and South Hiram to Cornish village, thence easterly and parallel with said road and twenty-five rods therefrom to westerly line of land of Lewis Gould, thence southerly on said westerly line to said road and continuing the same course to the Great Ossipee river, thence westerly up said river to said town line, thence northerly on said town line to the point begun at, together with the inhabitants thereof is hereby created a body politic and corporate by the name of the Porter Kezar Falls Village Corporation of Porter with all the rights and privileges granted by the laws of the state to similar corporations.'

This act shall take effect when accepted hy voters.

—meeting of voters, how called.

Section 2. This act shall take effect if accepted by a majority of the legal voters of the Porter Kezar Falls Village Corporation and also by a majority of the legal voters of territory to be annexed on or before July first, nineteen hundred fourteen, and F. E. Stearns and Monroe French, or either one of them, may call all meetings of the inhabitants of the territory to be annexed previous to the acceptance of this act by posting a notice, stating the time, place and objects of said meeting, in at least two public places in said territory, at least seven days before the time of holding said meeting.

Chapter 198.

An Act Relating to the Protection of Deer in the Town of Isle au Haut, in Hancock County.

Be it enacted by the People of the State of Mame, as follows:

Close time.

Whoever hunts, takes, catches, kills or destroys any deer in the town of Isle au Haut, in Hancock county, shall pay a fine of forty dollars and cost for each offense.

Chapter 199.

An Act Authorizing the City of Bath to Levy Assessments for Street Improvements.

Be it enacted by the People of the State of Maine, as follows:

Whenever the board of highways and sewers of the city of Bath shall have determined that a permanent improvement should be made by the construction, repair, alteration, renewal, or reconstruction of any sidewalk, or street gutter, and
