CHAP. 2

Section 10

Second: that the provisions of Section ten of Chapter two of the Revised Statutes are hereby extended and made applicable to the establishment of a national park and forest reserve as herein contemplated.

Third: that the Secretary of the Senate be requested to forward a copy of these resolutions to our Senators and Representatives in Congress.

Chapter 2.

Resolve, Declaratory of Certain Amendments of the Constitution of Maine.

Resolved, that at the election held September eleven, one thousand nine hundred and eleven, a majority of the votes was given in favor of Chapter two hundred and ten, of the Resolves of one thousand nine hundred and eleven, providing that Augusta is declared to be the seat of Government of this State; and a majority of the votes was given in favor of Chapter two hundred and twenty-one of the Resolves of one thousand nine hundred and eleven, providing that towns having a population of forty thousand inhabitants or more, according to the last census taken by the United States, be permitted to create a debt or liability which single or in the aggregate equals seven and one-half per centum of its last regular valuation, and that the increase in amount of debt be no greater than one-quarter of one per centum over the present rate of five per cent in any one year; and at the election held September ninth, one thousand nine hundred and twelve, a majority of the votes was given in favor of Chapter One of the resolves of one thousand nine hundred and twelve providing for the issuing of State Bonds for the purposes of building and maintaining State Highways; and that said several amendments were thereby adopted and by this declaration become a part of the Constitution.

Chapter 3.

Resolve, in favor of the town of Woodstock.

Resolved, that the sum of four hundred sixty-eight dollars and ninety-nine cents be appropriated to reimburse the town of Woodstock, in the county of Oxford and State of Maine, for money by it expended during the years nineteen hundred and

eight, nineteen hundred and nine and nineteen hundred and ten, in furnishing pauper supplies for Annie E. McLeod, the lawful wife of Don. B. McLeod, an alien and a state pauper, by reason of Section one, Chapter one hundred and forty-two, of the Public Laws of nineteen hundred and five. CHAP. 4

- Chapter 4.

Resolve, in favor of the town of Island Falls.

Resolved, that the sum of five hundred seventy-eight dollars and ninety-nine cents be appropriated to reimburse the town of Island Falls for the expense of commitment and support of Samoille Wan, an alien and state pauper, in the Eastern Maine Insane Hospital.

Chapter 5.

Resolve, in favor of the town of Phillips.

Resolved, that the sum of two hundred fifty-five dollars and eighty-six cents be, and hereby is, appropriated to be paid to the town of Phillips for the purpose of reimbursing said town for money paid out on account of George A. Stewart, a state pauper.

Chapter 6.

Resolve, in favor of the town of Paris.

Resolved, That the sum of one hundred and eighty-five dollars and eighty-nine cents be, and is hereby, appropriated to be paid the treasurer of the town of Paris for said town, the same being for pauper supplies furnished Annie McLeod by said town of Paris, the said Annie McLeod being the wife of an alien and not having any pauper residence in any incorporated town in the state of Maine, but was at the time of the furnishing said pauper supplies in need in the town of Paris, where she never either before or after marriage had any pauper residence.
