Resolve, in favor of the town of Peru.

Resolved, that there be, and hereby is, appropriated the sum of two hundred and nineteen dollars in favor of the town of Peru, in the county of Oxford, to reimburse said town for money paid for the support of Horace A. Clark, a state pauper, from May twenty-five, nineteen hundred and nine to January one, nineteen hundred and ten.

**Chapter 8.**

Resolve, in favor of the town of Moscow.

Resolved, That there be, and hereby is, appropriated the sum of fifty-seven dollars and seventy-three cents to be paid to the town of Moscow to reimburse said town for money paid for support of state paupers.

**Chapter 9.**

Resolve, in favor of the town of St. Agatha.

Resolved, that the sum of ninety-six dollars and thirty-eight cents be, and hereby is, appropriated to reimburse the town of St. Agatha in the County of Aroostook for money expended by it, in furnishing state paupers supplies.

**Chapter 10.**

Resolve in favor of Fred A. Thurlough.

Resolved, that the sum of three hundred fourteen dollars and ninety-eight cents, be and hereby is, appropriated for, and that said sum be paid to, Fred A. Thurlough for expenses incurred in defending suit in equity in the United States Circuit Court wherein The H. W. Huguley Company asked to have said Fred A. Thurlough enjoined from making seizures of liquor claimed to have been shipped into the State of Maine for illegal sale, and which bill has been dismissed from said United States Court without costs.
