**Chapter 15.**

Resolve, to provide Steel Cases for Regimental Rolls.

Resolved, that there be, and hereby is, appropriated the sum of fifteen hundred dollars for the year nineteen hundred and thirteen for the purchase of suitable steel filing cases for the regimental rolls of Maine organizations which served in the war for suppression of the Rebellion, eighteen hundred and sixty-one to eighteen hundred and sixty-five, the same to be expended under the direction of the Adjutant General of the state.

Resolved, that the sum of five hundred ninety-two dollars and eighty-one cents be, and the same is hereby appropriated, to be paid by the Treasurer of State to the city of Biddeford, out of moneys of the state not otherwise appropriated, for money expended by the city of Biddeford for the care and support of Joseph Leblonde, an insane, alien state pauper, and said sum shall be paid only on vouchers produced by said city of Biddeford and approved by the governor and council.
