CHAP. 56

Chapter 56.

Resolve, in Favor of the Commissioner of Agriculture in His Capacity as Sealer of Weights and Measures.

Com'r of Agriculture in favor of.

Resolved, that there be, and hereby is, appropriated the sum of two thousand five hundred dollars (\$2,500) for the year one thousand nine hundred and thirteen and the sum of two thousand five hundred dollars (\$2,500) for the year one thousand nine hundred and fourteen to be expended by the Commissioner of Agriculture as Sealer of Weights and Measures, to carry out the provisions of chapter eighty-two (82) of the Public Laws of nineteen hundred and eleven.

Approved February 20, 1913.

Chapter 57.

Resolve in favor of the Officers of the Senate at the Organization of That Body, January One, Nineteen Hundred and Thirteen.

Officers of seventyfifth legis-lature, in favor of.

Resolved, that there be and hereby is appropriated the sum of two hundred and forty-one dollars for "ervices of officers of the Senate of the Seventy-fifth Legislature, for attendance at organization of the Seventy-sixth Legislature, January first, nineteen hundred and thirteen, as follows:
