#### Chapter 65.

Chap. 65

Resolve, Appropriating Money for Expenses of the Electoral College.

Resolved, that there be and hereby is appropriated the sum of two hundred and seventy-one dollars to defray the expenses of the Electoral College of nineteen hundred and thirteen.

Electoral college, to defray expenses of.

Approved February 26, 1913.

#### Chapter 66.

Resolve, in Favor of the Town of Castine.

Resolved, that the sum of three hundred and sixty-three dollars and sixty-five cents be and hereby is appropriated to be paid to the town of Castine, in the County of Hancock and State of Maine, to reimburse said town for money expended in nineteen hundred and five, nineteen hundred and six, nineteen hundred and seven, nineteen hundred and eight, in furnishing pauper supplies, board and lodging to Terence O'Reilly, an alien State pauper.

#### Chapter 67.

Resolve, in Favor of the Maine Industrial School for Girls at Hallowell, to Provide for the Payment of Unused Interest on Trust Funds.

Resolved, that there be and hereby is appropriated in favor of the Maine Industrial School for Girls at Hallowell, the sum of one thousand two hundred sixty dollars and six cents, such sum being the amount of unused interest on trust funds deposited in the state treasury, for the years nineteen hundred nine, nineteen hundred ten, nineteen hundred eleven and nineteen hundred twelve.

#### Chapter 68.

Resolve, in Favor of the Maine Industrial School for Girls at Hallowell, to Provide for the Payment of Interest on Trust Funds Deposited in the State Treasury.

Resolved, that there be and hereby is appropriated in favor of the Maine Industrial School for Girls at Hallowell, the sum of five hundred and forty dollars and ninety-six cents for the year nineteen hundred and thirteen and a like sum for the year nine-

CHAP. 69 teen hundred fourteen, such sums being the amount of the interest payable on the Lane, Shaw, Hopkins and Mustard funds, so called, deposited in the state treasury.

#### Chapter 69.

Resolve, in Favor of the State School for Boys at South Portland for Permanent Improvements and Insurance.

State School for Boys, in favor of.

Resolved, that there be and hereby is appropriated in favor of the State School for Boys at South Portland, the sum of three thousand, five hundred dollars for the year nineteen hundred and thirteen, and the sum of one thousand five hundred dollars for the year nineteen hundred fourteen; said sums to be expended under the direction of the trustees of juvenile institutions, for painting, extending sewer and insurance.

Approved February 26, 1913.

#### Chapter 70.

Resolve, in Favor of the State School for Boys at South Portland for General Maintenance.

State School for Boys, in favor of.

Resolved, that there be and hereby is appropriated for the State School for Boys at South Portland, the sum of thirty-six thousand five hundred dollars for the year nineteen hundred thirteen, and the sum of thirty-six thousand five hundred dollars for the year nineteen hundred fourteen; said sums to be expended under the direction of trustees of juvenile institutions, for maintenance of said school.

#### Chapter 71.

Resolve, in Favor of the Eastern Maine Insane Hospital for Maintenance and Support.

Eastern Me. Insane Hospital in favor of. Resolved, that there be and is hereby appropriated the sum of one hundred and forty-three thousand, two hundred eighty-seven dollars and sixteen cents (\$143,287.16), to be paid to the Eastern Maine Insane Hospital for the use of said institution for the year nineteen hundred and thirteen, and one hundred forty-five thousand nine hundred ninety-one dollars and sixteen cents (\$145,991.16), for the use of said institution for the year nineteen hundred and fourteen, for maintenance and
