**Chapter 77.**

CHAP. 77

Resolve, in Favor of the Town of Kingman for Repairing a Bridge in Said Town Across the Mattawamkeag River.

Resolved, that there be and hereby is appropriated the sum of three hundred and fifty dollars (\$350) to aid the town of Kingman in repairing a bridge across the Mattawamkeag River, provided that the town of Kingman appropriates the sum of three hundred and fifty dollars (\$350) for the same purpose; both sums to be expended under the supervision of the State Highway Department.

**Chapter 78.**

Resolve, in Favor of Maria A. Sylvester of Augusta.

Resolved, that there be paid to Maria A. Sylvester, sister of Dummer Sylvester, late of Etna, in the county of Penobscot and State of Maine, the sum of ten dollars per month, payable quarterly, from the fund appropriated for military pensions, and to begin January first, nineteen hundred thirteen, in lieu of state aid now received of four dollars per month.

**Chapter 79.**

Resolve in Favor of the Maine Insane Hospital for Maintenance and Support for the Year Nineteen Hundred and Fourteen.

Resolved, that there be and hereby is appropriated the sum of two hundred ten thousand dollars, for the year nineteen hundred and fourteen for the use of the Maine Insane Hospital, for the full support of all state charges for the year nineteen hundred and fourteen; said sum to be expended under the direction of the Trustees of Insane Hospitals.

**Chapter 80.**

Resolve in Favor of the Maine Insane Hospital for Maintenance and Support for the Year Nineteen Hundred and Thirteen.

Resolved, that there be and hereby is appropriated the sum of two hundred four thousand dollars, for the year nineteen hundred and thirteen, for the use of the Maine Insane Hospital,

Resolve, in Favor of E. B. Weeks and Isaac F. Tibbetts, Both of Old Town.

E. B. Weeks and Isaac F. Tibbetts, in favor of.

Resolved, that the sum of eighty dollars and twenty-three cents be and hereby is appropriated to be paid to E. B. Weeks and Isaac F. Tibbetts both of Old Town, for lumber furnished to and used by Penobscot tribe of Indians at Old Town, for construction of side walks on Indian Island situated in the Penobscot River opposite the city of Old Town, Maine.

### Chapter 82.

Resolve, for the Construction of a Dormitory at the Farmington State Normal School.

Farmington State Normal School, in favor of dormitory.

Resolved, that there be and hereby is appropriated the sum of twenty thousand dollars for the year nineteen hundred thirteen and the sum of twenty-five thousand dollars for the year nineteen hundred fourteen, to be expended under the direction of the state normal school trustees for the construction of a dormitory at the Farmington State Normal School.

### Chapter 83.

Resolve in Favor of a Co-operative Survey of the Boundary Line Between the State of Maine and the State of New Hampshire.

Survey of boundary line between Maine, and New Hampshire, in favor of.

Resolved, Section 1. That the Governor of the State be authorized to appoint a surveyor on the part of the State of Maine, who shall have power under his direction and in conjunction with the surveyor to be appointed on the part of the State of New Hampshire, to ascertain, survey and mark the dividing line between the State of Maine and the State of New Hampshire and in conjunction with the proper county and town officials of the counties and towns intersected by said state line, erect or cause to be erected permanent monuments at the place of intersection of any county, town or highway line with
