said state line, and said monuments in addition to such words, letters and dates thereon as may be deemed necessary shall have the elevations above sea level indicated upon them.

Section 2. The sum of thirty-five hundred dollars is hereby appropriated to be used therefor on the part of the State of Maine when a like sum shall have been appropriated by the State of New Hampshire to defray its part of the expenses of said joint survey and markings.

Section 3. On completion of said survey the boundary line so marked shall be and is hereby accepted as the official boundary line between the State of Maine and the State of New Hampshire.

Chapter 84.

Resolve, in Favor of Indian Township for the Repair of Roads and Bridges.

Resolved, that there be and hereby is appropriated the sum of fifteen hundred dollars (\$1500) in the year nineteen hundred and thirteen and fifteen hundred dollars (\$1500) in the year nineteen hundred and fourteen for the repair of roads and bridges in Indian Township, in the county of Washington; said appropriation to be expended under the supervision of the State Highway Department.

Chapter 85.

Resolve, in Favor of E. and I. K. Stetson, Agents, and Charles P. Webber for Reimbursement for Certain Taxes Paid Under a Mistake of Fact in Township Eight, Range Four, N. B. P. P.

Resolved, that the sum of forty dollars and fifty-six cents be and hereby is appropriated to be paid, three-fourths thereof to E. and I. K. Stetson, agents, and one-fourth thereof to Charles P. Webber to reimburse them for taxes paid to the state upon supposed public lots in township eight, range four, N. B. P. P. in Washington County; it being afterwards ascertained that there are no public lots in said township.
