CHAP. 109**Chapter 109.**

Resolve, Providing a State Pension for Rosa Prentiss.

Resolved, that there be paid to Rosa Prentiss, widow of Leander Prentiss of Lewiston, the sum of six dollars per month, payable quarterly, from the fund appropriated for military pensions, beginning April first, nineteen hundred and thirteen.

**Chapter 110.**

Resolve, in Favor of Raising and Repairing the Bridge Over Garland's Brook in the Town of Mariaville.

Resolved, that there be and hereby is appropriated the sum of one thousand dollars for the purpose of raising and repairing the bridge across Garland's brook in the town of Mariaville; said sum to be expended under the supervision of the state highway department.

**Chapter 111.**

Resolve, in Favor of the Town of Whitneyville for Extra Expense in Repairing a Bridge.

Resolved, that the sum of four hundred forty-five dollars and sixteen cents, (\$445.16) be and is hereby appropriated to be paid to the town of Whitneyville in Washington County, as reimbursement for extra expense in connection with the building of abutment and repair of highway bridge across the Machias River, as provided under chapter one hundred and fifty-three of the resolves of nineteen hundred and nine.

**Chapter 112.**

Resolve in Aid of the Educational Work of Greeley Institute.

Resolved, that there be and hereby is appropriated, to be paid to the trustees of Greeley Institute the sum of five hundred (\$500) dollars for the use and benefit of said institute in carrying on its educational work.
