## CHAP. 123

**Chapter 123.**

Resolve, for Aid in Building a Road in the Town of Rockport.

Rockport,  
town of, in  
aid of  
building  
road in.

Resolved, that there be, and hereby is, appropriated the sum of one thousand dollars (\$1000) to aid the town of Rockport in the reconstruction of a section of main thoroughfare through West Rockport, connecting the state road of Rockport with the state road of Hope, provided that the sum of one thousand dollars (\$1000) be furnished by appropriation, or otherwise, by the town of Rockport, for the same purpose; both sums to be expended under the supervision of the state highway department.

Approved March 6, 1913.

**Chapter 124.**

Resolve, in Favor of Peter W. Ranco, Representative of the Penobscot Tribe of Indians.

Resolved, that the sum of one hundred and twenty dollars be and hereby is appropriated to be paid to Peter W. Ranco, representative of the Penobscot tribe of Indians, for travel and attendance at the session of the seventy-sixth legislature.

**Chapter 125.**

Resolve, in Favor of Peter J. Newell, Representative of the Passamaquoddy Tribe of Indians.

Resolved, that the sum of one hundred and twenty (120) dollars be and is hereby appropriated to pay Peter J. Newell, representative of the Passamaquoddy tribe of Indians, for his travel and attendance at the session of the seventy-sixth legislature.

**Chapter 126.**

Resolve, Making Specific Appropriations for Buildings at the University of Maine.

Resolved, that, from any moneys in the treasury not otherwise appropriated there is hereby specifically appropriated, for the purpose of defraying the cost of erecting a physical-chemical laboratory at the University of Maine, the sum of seventy-five thousand dollars; for the purpose of the partial erection

of a dormitory for women, the sum of twenty thousand dollars.

CHAP. 127

Payment of one-half of the amount of each of said appropriations shall be made to the University during the year one thousand nine hundred and thirteen, and of the remainder during the year one thousand nine hundred and fourteen.

One half of above for 1913 and one half for 1914.

### Chapter 127.

Resolve, in Favor of the Western State Normal School for the Purchase of Equipment for the Manual Training Department.

Resolved, that there be and hereby is appropriated in favor of the Western State Normal School at Gorham the sum of one thousand five hundred dollars for the year nineteen hundred thirteen, and the sum of two thousand dollars for the year nineteen hundred fourteen; both said amounts to be expended under the direction of the trustees of the state normal schools for the purchase of equipment for the manual training department.

### Chapter 128.

Resolve, for Aid in Repairing the "Pond" Road, So Called, in the Town of Readfield.

Resolved, that there be and hereby is appropriated the sum of one thousand dollars (\$1000) for the purpose of repairing the "Pond" road, so called, connecting the Kent's Hill road with the Mount Vernon road, in the town of Readfield; provided that the town of Readfield appropriates the sum of one thousand dollars (\$1000) for the same purpose; both sums to be expended under the direction of the state highway department.

### Chapter 129.

Resolve, in Aid of Rebuilding the Lower Bridge, So Called, Across the Mattawamkeag River in Moro Plantation.

Resolved, that there be and hereby is appropriated the sum of twenty-five hundred dollars (\$2500) to aid in rebuilding the lower bridge, so-called, in Moro plantation, in the county of Aroostook, provided that there be raised and appropriated

Moro Pl. in aid of building a bridge in.
