CHAP. 127

Payment of one-half of the amount of each of said appropriations shall be made to the University during the year one thousand nine hundred and thirteen, and of the remainder during the year one thousand nine hundred and fourteen.

One half of above for 1913 and one half for 1914.

Chapter 127.

Resolve, in Favor of the Western State Normal School for the Purchase of Equipment for the Manual Training Department.

Resolved, that there be and hereby is appropriated in favor of the Western State Normal School at Gorham the sum of one thousand five hundred dollars for the year nineteen hundred thirteen, and the sum of two thousand dollars for the year nineteen hundred fourteen; both said amounts to be expended under the direction of the trustees of the state normal schools for the purchase of equipment for the manual training department.

Chapter 128.

Resolve, for Aid in Repairing the "Pond" Road, So Called, in the Town of Readfield.

Resolved, that there be and hereby is appropriated the sum of one thousand dollars (\$1000) for the purpose of repairing the "Pond" road, so called, connecting the Kent's Hill road with the Mount Vernon road, in the town of Readfield; provided that the town of Readfield appropriates the sum of one thousand dollars (\$1000) for the same purpose; both sums to be expended under the direction of the state highway department.

Chapter 129.

Resolve, in Aid of Rebuilding the Lower Bridge, So Called, Across the Mattawamkeag River in Moro Plantation.

Resolved, that there be and hereby is appropriated the sum of twenty-five hundred dollars (\$2500) to aid in rebuilding the lower bridge, so-called, in Moro plantation, in the county of Aroostook, provided that there be raised and appropriated

Moro Pl. in aid of building a bridge in.

CHAP. 130 by the county of Aroostook, the plantation of Moro, and the town of Hersey, or otherwise, the sum of twenty-five hundred dollars (\$2500) for the same purpose; both sums to be expended under the supervision of the State highway department.

Chapter 130.

Resolve, for the Improvement of the State Park on the Easterly Side of State Street.

Resolved, that there be and hereby is appropriated for the improvement of the state park on the easterly side of State street the sum of two thousand dollars for the year nineteen hundred thirteen, and two thousand dollars for the year nineteen hundred fourteen; both said sums to be expended under the supervision of the state park commission in accordance with chapter fifty-seven of the private and special laws of nineteen hundred and eleven.

Chapter 131.

Resolve, in Favor of the Western State Normal School at Gorham for Repairs and Permanent Improvements.

Resolved, that there be and hereby is appropriated in favor of the western state normal school at Gorham the sum of fifteen hundred dollars for the year nineteen hundred thirteen and the sum of fifteen hundred dollars for the year nineteen hundred fourteen, such sums to be expended under the direction of the trustees of the state normal schools, for repairs and permanent improvements at said school.

Chapter 132.

Resolve, in Favor of Grenville M. Donham, for Four Hundred Copies of the Maine State Year Book and Legislative Manual.

Resolved, that the sum of six hundred dollars be and hereby is appropriated to be paid to Grenville M. Donham, of Portland, for four hundred copies of the Maine state year book and legislative manual of nineteen hundred twelve and nineteen hundred thirteen.
