CHAP. 219 the commissioners of inland fisheries and game, when the balance necessary to erect said screen, as found by said commissioners, shall have been raised by the citizens of Washington county and paid to the treasurer of state for this purpose. Town of East Ma-chias shall care for and

Provided, further, that this appropriation shall not be available until the town of East Machias shall have, in legal town meeting, and having an article in the warrant for said town meeting, for that purpose, by vote of record, voted to assume all liability, for the keeping of said screen at all times in repair and free from sticks, leaves and all debris, so that the same will not become clogged and prevent the free running of water through the same.

Chapter 219.

Resolve, in Favor of Lizzie Bean.

Resolved, that there be and hereby is appropriated three hundred dollars per annum for the years nineteen hundred and thirteen and nineteen hundred and fourteen, the said money to be paid Lizzie Bean of Passadumkeag in quarterly payments of seventy-five dollars each, under the supervision of the governor and council.

Chapter 220.

Rosolve, in Favor of the Purchase of the Maine State Year Book for the Years Nineteen Hundred and Thirteen and Nineteen Hundred and Fourteen.

Resolved, that the secretary of state be authorized to contract with the publishers of the Maine State Year Book for the purchase of six hundred (600) copies of said book for the year nineteen hundred and thirteen, also for six hundred (600) copies of said book for the year nineteen hundred and fourteen, at a price not to exceed one dollar and fifty cents (\$1.50) per copy.

Said contract shall stipulate that the books shall be delivered to the secretary of state on or before the first day of August for each year; otherwise, said contract shall be void. The secretary of state is hereby forbidden to accept said books on behalf of the state, after the dates herein provided.

Chapter 221.

Resolve for Laying the County Taxes for the Year Nineteen Hundred and Thirteen.

Whereas, the appropriations called for in this resolve are immediately necessary for the preservation of the public health and safety, and in the opinion of this legislature constitute an emergency as contemplated by the constitution, be it therefore

Resolved, that the sum annexed to the counties in the following schedule is hereby granted as a tax on each county respectively to be appropriated, assessed, collected and applied to the purpose of paying the debts and necessary expenses of the same and for other purpose of law, for the year one thousand nine hundred and thirteen:
