Resolved, the Senate and House concurring, that the passage of such legislation will result in joint benefit to the farmers and fishermen and ultimately to the consumers of sea food. Therefore, the legislature of Maine respectfully requests the Maine delegation in Congress to support the pending Federal legislation for the elimination of dogfish and said shark species by a Federal bounty as indicated above.

Approved March 27, 1913.

CHAP. 223

Maine delegation in congress requested to support pending measure.

Chapter 223.

Resolve, in Favor of the Maine Wesleyan Seminary and Woman's College for the Promotion of Certain Practical Sciences.

Resolved, that the sum of twenty-four hundred dollars be, and is hereby appropriated for the use and benefit of the Maine Wesleyan Seminary and Woman's College in the promotion, instruction and illustrating by doing of agriculture, dairying, poultry raising and orcharding on the farm belonging to the said institution. Twelve hundred dollars of this appropriation to be paid to the treasurer of trustees of this institution on or before the first day of July, nineteen hundred thirteen, and the same amount payable on or before the first day of July, nineteen hundred fourteen.

Chapter 224.

Resolve, in Favor of Screening Squa Pan Lake, So Called, in Aroostook County.

Resolved, that the sum of two hundred and fifty dollars be and is hereby appropriated for the year nineteen hundred and thirteen for the purpose of screening the outlet of Squa Pan lake, in Aroostook county, to be expended under the direction of the commissioners of inland fisheries and game, when the balance necessary to erect said screen, as found by said commissioners, shall have been raised by the citizens of Aroostook county, and paid to the treasurer of state for this purpose.

Squa Pan lake, in favor of screening of.

Provided, further, that this appropriation shall not be available until the town of Presque Isle shall have, in legal town meeting, and having an article in the warrant for said town meeting for that purpose, by vote of record, voted to assume all liability for the keeping of said screen in repair and at all times free from sticks, leaves and all debris, so that the same will not become clogged and prevent the free running of the water through the same.

Town of Presque Isle shall care for and repair screen.

Approved March 28, 1913.
