**Chapter 242.**

CHAP. 242

Resolve, in Favor of the Girl's Orphanage of Lewiston for Maintenance.

Resolved, that there be and hereby is appropriated the sum of two thousand five hundred dollars to be paid to the Girl's Orphanage of Lewiston for the year nineteen hundred and thirteen and two thousand five hundred dollars for the year nineteen hundred and fourteen, for maintenance.
