Resolved, that there be and hereby is appropriated the sum of seven hundred and fifty dollars to be paid the Presque Isle General Hospital of Presque Isle, for the year nineteen hundred and thirteen and the sum of seven hundred and fifty dollars for the year nineteen hundred and fourteen, for maintenance.

Resolve, in Favor of the Maine School for the Deaf for Maintenance.

Resolved, that there be and hereby is appropriated the sum of twenty-two thousand dollars to be paid to the Maine School for the Deaf at Portland, for the year nineteen hundred and thirteen and twenty-two thousand dollars for the year nineteen hundred and fourteen, for maintenance.

Resolve, in Favor of the Temporary Home for Women and Children, for Maintenance.

Resolve, in Favor of the Maine General Hospital for Maintenance.

Resolved, that there be and hereby is appropriated the sum of nine thousand dollars to be paid to the Maine General Hospital, for the use of said institution for the year nineteen hundred and thirteen and nine thousand dollars, to be paid to said institution for its use for the year nineteen hundred and fourteen, for maintenance.
