Chapter 280.

CHAP. 280

Resolve, in Favor of the Maine Anti-Tuberculosis Association for Maintenance.

Resolved, that there be and hereby is appropriated the sum of one thousand dollars to be paid to the Maine Anti-Tuberculosis Association at Waterville, for the year nineteen hundred and thirteen and one thousand five hundred dollars for the year nineteen hundred and fourteen, for maintenance, to be used in the discretion of the trustees of said association, subject to the approval of the governor and council, for charitable purposes in the treatment of patients by said institution.

Maine Anti-tuberculosis Ass'n in favor of.

Approved April 4, 1913.

Chapter 281.

Resolve, in Favor of the Bangor Anti-Tuberculosis Association for Maintenance.

Resolved, that there be and hereby is appropriated the sum of one thousand dollars to be paid to the Bangor Anti-Tuberculosis Association of Bangor, for the year nineteen hundred and thirteen, and one thousand dollars for the year nineteen hundred and fourteen, for maintenance, to be used in the discretion of the trustees of said association, subject to the approval of the governor and council, for charitable purposes in the treatment of patients by said institution.

Bangor Anti-tuberculosis Ass'n, in favor of.

Approved April 4, 1913.

Chapter 282.

Resolve, in Favor of the Central Maine Association for the Relief and Control of Tuberculosis for Maintenance.

Resolved, that there be and hereby is appropriated the sum of five thousand dollars to be paid to the Central Maine Association for the Relief and Control of Tuberculosis, Fairfield, for the year nineteen hundred and thirteen, and seven thousand five hundred for the year nineteen hundred and fourteen, for maintenance, to be used in the discretion of the trustees of said association, subject to the approval of the governor and council, for charitable purposes in the treatment of patients by said association.

Central Maine Ass'n, for control of tuberculosis, in favor of.
