Resolve, in Favor of the North Yarmouth Academy for Repairs and Improvements.

Resolved, that there be and hereby is appropriated to be paid to the trustees of the North Yarmouth Academy for the use and benefit of that institution for the year nineteen hundred and thirteen the sum of five hundred dollars, and for the year nineteen hundred and fourteen the sum of five hundred dollars, the same to be expended for the repair and improvement of the buildings and fixtures and the improvement of the grounds of said institution.
