**CHAP. 295** in accordance with the following resolve for the use of the state; and said commissioner shall superintend said printing.

Compensation of commissioner and for printing etc.

—vacancy in office of com'r, how filled.

Appropriation, amount and how drawn.

Resolved, that the governor and council be and hereby are authorized to arrange the details of the services and compensation of said commissioner, and to provide for the printing and binding thereof by the state printer and binder; provided that the compensation of said commissioner, his expense for clerical assistance and stationery, for said revision and report, shall not exceed the sum of ten thousand dollars. In the event of a vacancy occurring in the office of commissioner named herein, by death, resignation or otherwise, the governor, with the advice and consent of the council, is authorized to fill said vacancy.

Resolved, that there be and hereby is appropriated out of any moneys in the treasury not otherwise appropriated the sum of ten thousand dollars for the purpose above specified, to be paid on warrants drawn by the governor, with the advice and consent of the council, in such amounts and at such times as the governor and council may approve.

### Chapter 295.

Resolve, in Favor of the Maine Insane Hospital for the Erection of Piazzas.

Maine Insane Hospital, in favor of.

Resolved, that there be and hereby is appropriated the sum of ten thousand dollars, for the year nineteen hundred and thirteen, and five thousand dollars, for the year nineteen hundred and fourteen, for the use of the Maine Insane Hospital, for erection of piazzas on Harlow and Sanborn wings, said sums to be expended under the direction of the trustees of insane hospitals.

### Chapter 296.

Resolve, Appropriating Money to Reimburse Charles M. Conant, Chairman of the Committee on Ways and Bridges for Certain Committee Expenses.

Conant, Charles M., in favor of.

Resolved, that there be and hereby is appropriated the sum of thirty-one dollars and fifty-five cents to be paid to Charles M. Conant of Winterport, chairman of the joint standing committee on ways and bridges, to reimburse him for money expended for transportation of the members of the committee to Old Town and return.

Approved April 4, 1913.
