Chapter 7.

An Act Additional to Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Fishing in Island Pond and Its Tributaries, in the Towns of Harrison and Waterford, in the Counties of Cumberland and Oxford.

Be it enacted by the People of the State of Maine, as follows:

Cumberland
and Oxford
counties.

—penalty.

No person shall fish for, take, catch or kill any kind of fish at any time in Island pond, so-called, or in any of the tributaries to said pond, which waters are situated in the town of Harrison, in the county of Cumberland, and in the town of Waterford, in the county of Oxford. No person shall have in possession at any time any kind of fish taken in violation of any provision of this section. Whoever violates any provision of this act shall pay a fine of not less than ten dollars nor more than thirty dollars and costs for each offense; and in addition thereto one dollar for each fish taken, caught, killed or had in possession in violation of any provision of this act.

Chapter 8.

An Act to Amend Section Two of Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Ice Fishing in Androscoggin Lake, in the Counties of Androscoggin and Kennebec.

Be it enacted by the People of the State of Maine, as follows:

amended.

—ice fishing
permitted.

So much of section two of chapter thirty-two of the Revised Statutes, as amended by chapter two hundred six of the Public Laws of nineteen hundred thirteen, as prohibits fishing through the ice, in accordance with the general law of the State relating to ice fishing, on Wednesday of each week, in Androscoggin lake, in the counties of Androscoggin and Kennebec, is hereby repealed.
