CHAP. 134 Section 2. Whoever violates any provision of section one of
 —penalty. this act shall pay a fine of not less than ten dollars nor more
 than thirty dollars and costs for each offense.

Chapter 134.

An Act to Amend Section Two of Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Fishing in the Davis Ponds, in Guilford and Willimantic, in the County of Piscataquis.

Be it enacted by the People of the State of Maine, as follows:

Ice fishing
 permitted
 in the Davis
 ponds.

So much of section two of chapter thirty-two of the Revised Statutes, as amended by chapter two hundred six of the Public Laws of nineteen hundred thirteen, as prohibits fishing through the ice in the four Davis ponds, so-called, in Guilford and Willimantic, in the county of Piscataquis, in accordance with the general law of the State, relating to ice fishing, is hereby repealed.

Chapter 135.

An Act Additional to Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Fishing in Certain Waters in Oxford County.

Be it enacted by the People of the State of Maine, as follows:

Fly fishing

Section 1. No person shall fish for, take, catch or kill any kind of fish at any time, in any of the tributaries to Aziscohos lake, or in any of the tributaries to Parmachenee lake, or in any of the tributaries to the Magalloway river above Aziscohos dam, all in the county of Oxford; nor shall any person fish for, take, catch or kill any kind of fish, at any time, in Aziscohos lake or in Parmachenee lake or in Long pond or in the Magalloway river above Aziscohos dam, or in Little Magalloway river below Wheeler dam, which waters are situated in township four, range five, W. B. K. P., otherwise called Oxbow town, township four, range six, W. B. K. P., otherwise called Bowmantown, township five, range five, W. B. K. P., otherwise called Parmachenee town, township five, range four, W. B. K. P., otherwise called Lynchtown, township five, range three, W. B. K. P., otherwise called Parkertown, and in Lincoln

plantation and in Magalloway plantation, all in the county of Oxford, except by the ordinary method of casting with artificial flies or fly fishing. No person shall take, catch or kill in any one day, more than five pounds of fish in all, or not more than ten fish, even though the ten fish caught and killed weigh less than five pounds, in said Aziscohos lake, Parmachenee lake, Long pond, the Magalloway river above Aziscohos dam, or in Little Magalloway river below Wheeler dam; nor shall any person have in possession in any one day, more than five pounds of fish in all, or not exceeding ten fish, even though they weigh less than five pounds, taken in said waters. No resident of this State shall carry away or transport in any one day more than five pounds of fish, or not more than one fish if it exceeds five pounds in weight, taken in any of said waters; nor shall any non-resident carry away or transport, in any one day, more than three pounds of fish, or not more than one fish if it exceeds three pounds in weight, taken in any of said waters, except that fish legally taken in said waters may be transported from the place where caught to a lodge, camp, dwelling house or hotel situated in the above named territory. No person shall have in possession at any time any kind of fish taken in violation of any provision of this section.

CHAP. 136

Not more than five pounds of fish in one day may be caught, or carried away.

—non-resident limited to three pounds.

—exception.

Section 2. Whoever violates any provision of section one of this act shall pay a fine of not less than ten dollars nor more than thirty dollars and costs of prosecution for each offense; and in addition thereto one dollar for each fish taken, caught, killed or had in possession, in violation of any provision of this act.

—penalty for violation.

Chapter 136.

An Act Providing Punishment for Escapes from Jail.

Be it enacted by the People of the State of Maine, as follows:

Whoever, being lawfully detained for any criminal offense, in any jail or other place of confinement, breaks or escapes therefrom, or forcibly attempts to do so, shall be punished, if such prisoner was in custody for a felony, by imprisonment for not less than one, nor more than seven years; and if for any other offense, by imprisonment for not exceeding one year; such imprisonment shall commence after the completion of any sentence imposed for the crime for which he was then in custody.

Penalty for attempting to escape from jail, how imposed.
