**Chapter 226.**

CHAP. 226

An Act Additional to Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Prohibiting Fishing in Mud Pond, Mirror Lake, Sometimes Called Parkis Pond, and Their Tributaries, and Bog Stream and Its Tributaries Down as Far as North Pond Stream, in Franklin and Kennebec Counties.

*Be it enacted by the People of the State of Maine, as follows :*

No person shall fish for, take, catch or kill any kind of fish at any time in Mud pond, or in Mirror lake, sometimes called Parkis pond, or in any of their tributaries, or in Bog stream, the outlet of said Mirror lake, or in any of the tributaries to said stream, down as far as North Pond stream, which waters are situated wholly or partly in the towns of Jay and Chesterville, in Franklin county, and in the town of Fayette, in Kennebec county; nor shall any person have in possession at any time any kind of fish taken in any of said waters. Whoever violates any provision of this act shall pay a fine of not less than ten dollars nor more than thirty dollars and costs of prosecution for each offense; and in addition thereto one dollar for each fish taken, caught, killed or had in possession in violation of any provision of this act.

Certain waters of Franklin and Kennebec counties closed to fishing.

**Chapter 227.**

An Act to Amend Section Two of Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Fishing in Carrabasset River and Its Tributaries above the Bridge at Bigelow.

*Be it enacted by the People of the State of Maine, as follows :*

So much of section two of chapter thirty-two of the Revised Statutes, as amended by chapter two hundred six of the Public Laws of nineteen hundred thirteen, as prohibits fishing in Carrabasset river and its tributaries above the bridge at Bigelow, in accordance with the general law of the State, is hereby repealed.

Carrabasset river and tributaries above bridge open to fishing.
