-deeds of lots. -officers corporation, Section 7. Deeds of lots in said cemetery may be recorded in the county registry of deeds of Oxford county.

Section 8. The officers of this corporation shall be a board of seven trustees, a clerk, a treasurer, and such other officers as its by-laws may prescribe, who shall hold office for such time and be elected in such manner as may be required by the by-laws of the corporation.

-treasurer shall give bonds. Section 9. The treasurer of said corporation shall be required to give bonds with sureties in such sum as the board of trustees may deem sufficient.

—annual and special meetings.

Section 10. The annual and special meetings of this corporaton shall be holden at such time and place and such notice thereof shall be given as the by-laws direct.

—first meeting. Section II. Any three of the corporators are hereby authorized to call the first meeting of this corporation by posting notices thereof in three public places in the vicinity, seven days at least before said meeting.

#### Chapter 162.

An Act to Amend Section Four of Chapter Thirty-one of the Private and Special Laws of Nineteen Hundred Five, Entitled, "An Act to Authorize the Houlton Water Company to Generate, Sell and Distribute Electricity," as Amended by Chapter One Hundred Six of the Private and Special Laws of Nineteen Hundred Seven.

Be it enacted by the People of the State of Maine, as follows:

Laws 1907, further amended.

Section four of chapter thirty-one of the Private and Special Laws of nineteen hundred five, as amended by chapter one hundred six of the Private and Special Laws of nineteen hundred seven, is hereby further amended by adding in line three after the word "aforesaid" thereof the words 'and for the purposes specified and stated in chapter three hundred forty-eight of the Private and Special Laws of nineteen hundred nine, and for the purpose of purchasing the plant and business of any person, partnership or corporation carrying on or doing any electric business in the town of Houlton; and by striking out the word "forty" in line four of said section four and inserting in lieu thereof the words 'one hundred and twenty; and by striking out the word "forty" in the sixth and seventh lines thereof and inserting in lieu thereof the words 'one hundred,' so that said section four, as amended, shall read as follows:

Corporation may hold real and personal estate 'Section 4. Said company or corporation may lease, purchase, acquire and hold real and personal estate, necessary and convenient for the purposes aforesaid and for the purposes

specified and stated in chapter three hundred forty-eight of CHAP, 163 the Private and Special Laws of nineteen hundred nine, and for the purpose of purchasing the plant and business of any person. partnership or corporation carrying on or doing any electric business in the town of Houlton, to an amount not exceeding one hundred and twenty thousand dollars; may sell and convey the same; and may issue, negotiate and sell its bonds to an amount not exceeding one hundred thousand dollars for the purposes stated in this act, and said bonds to the amount of one hundred thousand dollars may be purchased and held by the savings banks and trust companies of Maine.'

#### Chapter 163.

An Act to Authorize the Construction of a Weir in the Tide Waters of the Cobscook River in the Town of Lubec.

Be it enacted by the People of the State of Maine, as follows:

Section 1. A. J. Small of Lubec, in the county of Washington, is hereby authorized to build and maintain a weir for fishing purposes in front of his land in the tide waters of the Cobscook river, in said Lubec, providing, that said weir does not interfere with navigation, or the rights of others.

Section 2. The above mentioned weir shall be located as follows, to wit: commencing on the shore of said A. J. Small's land, and running in an easterly direction eight hundred feet, more or less, to a ledge on Cooper's island, owned by said A. I. Small; thence in a southeasterly direction three hundred feet, more or less; thence in a southwesterly direction seventy-five feet, more or less, to a ledge where the mouth of weir will be located; thence up the said shore of said A. J. Small's land in a southwesterly direction one hundred and seventy-five feet, more or less.

An Act to Provide for the Establishment of a Board of Recreation for the City of Portland.

Be it enacted by the People of the State of Maine, as follows: Establish-
