Chapter 118.

Resolve Appropriating Money to Aid in Building a Bridge across Sourdahscook Stream in the Town of Hampden and Providing for the Future Maintenance Thereof.

Town of Hampden, in favor of bridge across Sourdabscook stream in Resolved, That there be, and hereby is, appropriated the sum of one thousand dollars to aid in building a bridge across Sourdabscook stream in the town of Hampden, provided that there be appropriated by the town of Hampden the sum of one thousand dollars for the same purpose; provided further that any additional cost above two thousand dollars for said bridge shall be borne by said town of Hampden, and also that said bridge shall be kept in such repair as may be directed by the State Highway Commission, at the expense of the town of Hampden; all sums of money to be expended under the supervision of the State Highway Commission.

Chapter 119.

Resolve Appropriating Money to Aid in Building a Bridge in the Town of Crystal and Providing for the Future Maintenance Thereof.

Town of Crystal, in favor of bridge across Fish stream in.

Resolved, That there be, and hereby is, appropriated the sum of one thousand dollars to aid in building a bridge across Fish stream in the town of Crystal, provided that there be appropriated by the town of Crystal one thousand dollars for the same purpose; both sums to be expended under the supervision of the State Highway Commission; provided also that any additional cost above two thousand dollars shall be borne by said town of Crystal, and further provided that said bridge shall be kept in such repair, as may be directed by the State Highway Commission, at the expense of the town of Crystal.

Chapter 120.

Resolve Appropriating Money to Aid in Building a Bridge across Kenduskeag Stream in the Town of Corinth

Town of Corinth, in favor of bridge across Kenduskeag stream in. Resolved, That there be, and hereby is, appropriated the sum of five hundred dollars for the purpose of building a bridge across Kenduskeag stream in the town of Corinth, in Penobscot county; provided that there be appropriated by the town of Corinth, or otherwise, the sum of five hundred dollars for

the same purpose; provided also that any additional cost above CHAP. 121 one thousand dollars incurred in building said bridge shall be borne by the town of Corinth; all appropriations to be expended under the supervision of the State Highway Department.

Chapter 121.

Resolve Providing a State Pension for Jesse Bachelder.

Resolved, That there be paid Jesse Bachelder of Union the sum of twenty dollars per month, payable quarterly from the fund appropriated for military pensions, beginning January first, nineteen hundred fifteen and continuing during the pleasure of the Legislature and until otherwise ordered.

Resolve Appropriating Money to Aid in Repairing a Bridge across the Piscataguis River in the Town of Howland.

Resolved, That there be, and hereby is, appropriated the sum of three hundred dollars to aid in painting and replanking a bridge across the Piscataguis river in the town of Howland, provided that there be appropriated by said town of Howland the sum of three hundred dollars for the same purpose; both sums to be expended under the supervision of the State Highway Commission.

Chapter 123.

Resolve Appropriating Money to Aid in the Repair and Maintenance of the Gardiner and Randolph Bridge.

Resolved, That there be, and hereby is, appropriated the sum of one thousand dollars for the year nineteen hundred fifteen, and the sum of one thousand dollars for the year nineteen hundred sixteen, for the repair and maintenance of the Gardiner and Randolph bridge between Gardiner and Randolph, provided that the sum of one thousand dollars for the year nineteen hundred fifteen and the sum of one thousand dollars for the year nineteen hundred sixteen be appropriated by the city

Gardiner and Randolph bridge, in favor of.
