Public Laws of nineteen hundred thirteen. The share of the Chap. 143 State in said maintenance shall be paid out of the fund for administration and maintenance created by virtue of section thirty-three of said chapter one hundred thirty.

Chapter 143.

Resolve Appropriating Money to Repair the Bridges across Northeast Brock and Canoe Brook in Township Number Twenty-nine, Middle Division, in Washington County.

Resolved, That the sum of one hundred dollars be, and hereby is, appropriated for the purpose of repairing the bridges across Northeast brook and Canoe brook in township number twenty-nine, middle division, Washington county; the same to be expended under the direction of the county commissioners of said county.

Bridge across Northeast brook and Canoe brook, in favor of.

Chapter 144.

Resolve Appropriating Money to Aid in Building a Bridge across the South Branch of Dead River in the Plantation of Dallas.

Resolved, That there be, and hereby is, appropriated the sum of one thousand dollars to aid in building a bridge across the south branch of Dead river in the plantation of Dallas, in the county of Franklin, provided that there be appropriated by the said plantation of Dallas the sum of one thousand dollars for the same purpose; both sums to be expended under the supervision of the State Highway Commission; provided further that any additional cost of said bridge shall be borne by the plantation of Dallas; and said bridge shall be kept in such repair, by the plantation of Dallas as may be decided by the State Highway Commission.

Resolve Appropriating Money for the Reconstruction of Lord Bridge over Marsh Stream in the Town of Frankfort,

Resolved, That there be, and hereby is, appropriated the sum of four thousand dollars to be used and expended in the reconstruction of the so-called "Lord bridge," and approaches to

same, across Marsh stream in the town of Frankfort, on the road leading from Frankfort to Monroe; said sum to be expended under the supervision of the State Highway Commission.

Chapter 146.

Resolve Appropriating Money to Partially Reimburse the Town of Deblois for Money Expended in Building a Bridge.

Town of Deblois, reimbursed for money expended. Resolved, That there be, and hereby is, appropriated the sum of four hundred fifty dollars to be paid to the town of Deblois as partial reimbursement for money expended by said town in building a bridge across the Narraguagus river during the spring of nineteen hundred fourteen.

Approved March 22, 1915.

Chapter 147.

Resolve Appropriating Money to Repair a Bridge in the Town of Addison.

Town of Addison, in favor of bridge in. Resolved, That there be, and hereby is, appropriated the sum of one thousand dollars for the purpose of repairing Main river bridge in the town of Addison; said sum to be expended under the supervision of the State Highway Commission.

Chapter 148.

Resolve Appropriating Money to Aid in Repairing Seboeis Bridge in the Town of Howland.

Town of Howland, in favor of Seboeis bridge in. Resolved, That there be, and hereby is, appropriated the sum of two hundred dollars to aid in repainting and replanking the Seboeis bridge in the town of Howland, provided there be appropriated by said town of Howland the sum of two hundred dollars for the same purpose; both sums to be expended under the supervision of the State Highway Commission.
